**Final court decision:** Sentenced on 28<sup>th</sup> June 2010 to twelve years of detention.

### **Mansurkhon AKHMEDOV**

Last court decision: 25<sup>th</sup> May 2016, sentenced to 5 years imprisonment.

**Other information**: Arrested alongside Jonibek Turdiboyev. Prosecutors used the testimony of a jailed relative Madatjon Inamutdinov to convict him.

**Date and place of arrest:** 2010 in Navoi

**Charges:** Jailed for meeting with others to study the Koran and pray.

**Article of the criminal/civil/administrative code:** Criminal Code Article 244-1, Part 3 (a) ("Production and dissemination of materials containing a threat to public security and public order") and Article 244-2, Part 1 ("Creation, leadership or participation in religious extremist, separatist, fundamentalist or other banned organisations").

**Final court decision:** Sentenced on 28<sup>th</sup> June 2010 to nine years of detention.

### Mehrinisso HAMDAMOVA

Date of arrest: November 2009

**Charges:** Attempts to change the constitutional order of Uzbekistan

**Statement of defendant:** She was simply teaching Islam in a mosque in Karshi.



Article of the criminal/civil/administrative code or law: Article 159 ("attempts to change the constitutional order of Uzbekistan"), and article 244-1 ("preparation or distribution of materials threatening public security and public order").

Final court decision: In April 2010 she was sentenced to seven years in jail.

Place of detention: A camp of female prisoners in Zangiota District.

### **Zulhumor HAMDAMOVA**

**Charges:** Attempts to change the constitutional order of Uzbekistan.

**Statement of defendant:** She was simply teaching Islam in a mosque in Karshi.

Final court decision: In April 2010 she was sentenced to six and a half years in jail.

Place of detention: NSS secret police detention center, Yunusabad District, Tashkent.

**Other information**: Officials and Khudaiberdiyev's lawyer have refused to provide details of the case, stating its secretive nature.

## **Gayrat KHUSANOV**

**Date of arrest:** Between mid-May and 26<sup>th</sup> July 2012



**Statement of the defendants:** He was meeting to read the Koran, discuss his faith and to learn how to pray.

**Article of the criminal/civil/administrative code or law**: Criminal Code Article 244-1, Part 3 (a) ("Production and dissemination of materials containing a threat to public security and public order").

**Final court decision:** On 22<sup>nd</sup> November 2012, Yukorichirchik District Court sentenced him to seven years in prison.

Place of detention: Yangibazar Detention Centre in Tashkent Region

## **Davron KOMOLIDDINOV**

Age: 24 years

**Date and place of arrest**: On 4<sup>th</sup> March, 2016 in Krasnoyarsk, Russia.

**Charges**: Enciting ethnic, racial, or relgious hatred, attempt to undermine the constitutional order of Uzbekistan, participation in a religious extremist organization.

**Statement of the defendant**: While in Russia he accessed online sermons and teachings of religious leaders and performed Islamic prayers. He also accessed media from Uzebekistani imams and copied their photographs to his social media page.

Articles of the criminal code: Criminal Code Articles 156 ("Acts intended to humiliate ethnic honour and dignity, insult the religious or atheistic feelings of individuals, carried out with the purpose of inciting hatred, intolerance, or divisions on a national, ethnic, racial, or religious basis, as well as the explicit or implicit limitation of rights or preferences on the basis of national, racial, or ethnic origin, or religious beliefs"), 159 ("Attempts to change the Constitutional order"), and 244-2, Part 1 ("Creation, leadership or participation in religious extremist, separatist, fundamentalist or other banned organisations").

First court decision: Fergana Regional Court sentenced him to seven years in prison.

**Last court decision**: The sentence was upheld by the court of appeals.

Place of detention: Prison colony 64/61 in Karshi

**Other information**: Torture and ill treatment have been used against Komoliddinov to force false confessions to the crimes that he alleges he did not commit.

**Charge**: Possession of extremist materials

**Article of criminal/ civil/ administrative code**: Criminal Code Article 246 Part 1 ("Smuggling, that is carriage through the customs border without the knowledge of or with concealment from customs control of materials that propagandize religious extremism, separatism, and fundamentalism").

First court decision: Sentenced to a five-year prison term on 16<sup>th</sup> October 2013

**Last court decision**: November 2013 (appeal rejected).

**Other information**: Sermons downloaded to his mobile phone were deemed "extremist".

## **Ulugbek OTAKUZIYEV**

Date and place of arrest: 2010

**Charges:** Meeting with others to study the Koran and pray.

**Article of the criminal/civil/administrative code:** Criminal Code Article 244-1, Part 3 (a) ("Production and dissemination of materials containing a threat to public security and public order") and Article 244-2, Part 1 ("Creation, leadership or participation in religious extremist, separatist, fundamentalist or other banned organisations").

Last court decision: Sentenced on 28<sup>th</sup> June 2010 to nine years of detention.

Last court decision: 25<sup>th</sup> May 2016, sentenced to 5 years imprisonment.

**Other information**: Arrested alongside Mansurkhon Akhmedov. Prosecutors used testimony of a jailed relative Madatjon Inamutdinov to convict.

## **Khayrullo TURSUNOV**

Age: 38 years

Place of residence: Almaty, Kazakhstan

Date and place of arrest: 7<sup>th</sup> April 2012, Aktobe Kazakhstan, 13<sup>th</sup> March Uzbekistan

**Charges:** Extremist religious activity

**Statement of the defendant:** Practiced faith outside of state run mosques, fled to Kazakhstan. **First court decision in Kazakhstan:** On 9<sup>th</sup> April 2012, Aktobe City Specialized Administrative Court approved his detention, which was subsequently extended several times by the court.

**Other events:** On 25<sup>th</sup> October 2012, Kazakh Deputy General Prosecutor Khalimoc approved the decision to extradite.



**Second court decision:** On 22<sup>nd</sup> November 2012, Astana Regional Court referred Tursunov's appeal to Aktobe City Court No. 2.

**Third court decision:** On 25<sup>th</sup> December 2012, Judge Kusanova upheld the extradition.

**Fourth court decision:** On 18<sup>th</sup> January 2013, a panel of Judges at Aktobe Regional Court rejected Tursunov's appeal and upheld his extradition.

**Last court decision:** He was sentenced to six years in prison.

Other information: Just as Odilov's prison term was due to expire in January 2016, authorities imposed a further prison term. When Odilov's parents arrived at the camp near Tashkent on 1<sup>st</sup> Februrary 2016, officials told them that on the last day he had got into a fight. It is unknown which court issued Odilov the extended sentence or under which Criminal Code Article the extension was justified.

Punishments are arrest for up to 15 days or a fine of up to 100 times the minimum monthly wage).

First court decision: Imprisoned for 15 days

Last court Decision: Released with a fine of three-year official minimum wage

Place of detention: Ahangaran Police Station for 10 days, moved to a Detention Centre in

Tashkent Region for 5 days.

**Date of release:** 31<sup>st</sup> March 2016 **Duration of detention:** 15 days

Other information: He was fined more than three years' official minimum wage after his

release.

## **Tohar HAYDAROV**

**Other information:** The charges are believed to have been fabricated and came after relatives asked local police to help them force Tohar, a convert to Christianity, to return to Islam.

Mamazhanov was subjected to torture several times and placed in a cell with informers who tried to convince him to claim responsibility for unsolved crimes.
