**Other information:** He allegedly questioned on social media why Chhatrapati Shivaji's birthday was celebrated twice a year in a comment on a WhatsApp group. Members of the group asked for an apology, which he was refused. He was attacked the next day on the university campus at which he is a professor by students, teachers, and locals, and was thereafter arrested.
