## **USCIRF condemns sentencing of Baha'i women**

USCIRF (26.12.2022) - <https://bit.ly/3YQBkNg> - The United States Commission on International Religious Freedom (**USCIRF**) **condemned** Iran's sentencing of two Baha'i women who were former members of the imprisoned **Yaran Iran**, known as the Baha'i Seven.

Following an hour-long trial, Judge Iman Afshari of Branch 26 of the Tehran Revolutionary Court sentenced [Mahvash Sabet](#) (age 69) and [Fariba Kamalabadi](#) (age 60) to 10 years in prison. Both women previously [served](#) a 10-year sentence between 2008 and 2018 alongside five other Baha'is related to their social and spiritual work in the Iranian Baha'i community. Amid ongoing protests in Iran over mandatory religious headscarf laws and other restrictions on freedom, Iran's government has arrested [scores](#) of [Baha'is](#) and other [religious minorities](#).

*"Iran's relentless persecution of Mahvash Sabet and Fariba Kamalabadi is the latest in its decades-long campaign against the religious freedom of Baha'is. The Iranian government targets women in this community as part and parcel of a larger assault on the religious freedom of Iranian women in a desperate attempt to re-assert control at a time of unprecedented calls for freedom by the Iranian people,"* said USCIRF Commissioner [Sharon Kleinbaum](#). *"USCIRF urges the U.S. government to amplify the efforts of Iranians protesting for greater religious freedom and other rights. It should leverage the full force of its economic power against Iranian officials complicit in egregious religious freedom violations and continue to support the efforts of the United Nations Human Rights Council's [Independent International Fact-Finding Mission on the Islamic Republic of Iran](#) to document and investigate Iran's gross violations of human rights against those who peacefully assert their freedom of religion or belief."*

Iran's government considers Baha'is a "deviant sect" of Islam and has [systematically](#) denied the community freedom of religion or belief for decades. Baha'is are excluded from pursuing higher education, have their businesses shuttered, and face harassment and arrest by Iranian security forces. In recent years, the Execution of Imam Khomeini's Order (EIKO) has [seized](#) Baha'i properties that community members have owned for decades.

Following the outbreak of protests over mandatory headscarf laws for women in Iran, the government escalated its persecution of Baha'is and other religious minorities including Sunnis, Christians, Gonabadi Sufis, and Yarsanis. Iran has used the Baha'i practice of mixed-gender religious gatherings and the lack of mandatory headscarves for women as evidence that Baha'i women are immoral and represent a threat to the religiously-grounded public order that Iran's government endorses.

*"Iran's ongoing mistreatment of Baha'is lays bare its utter contempt for freedom of religion or belief. The international community cannot turn a blind eye to these outrageous violations,"* added USCIRF Commissioner [Eric Ueland](#). *"The U.S. Department of State should continue to engage constructively but frankly with the international community to combat the ongoing repression of religious minorities in Iran and give full support to other like-minded governments pursuing sanctions against Iranian officials complicit in these restrictions. Rights abusers in Iran need to be held accountable for their persecution and unjustified arrests of religious groups."*

In its [2022 Annual Report](#), USCIRF recommended that the U.S. State Department redesignate [Iran](#) as a Country of Particular Concern (CPC) for its systematic, ongoing, and egregious religious freedom violations, which Secretary of State Antony J. Blinken [announced](#) a few weeks ago.

USCIRF published a [country update](#) on religious freedom conditions in Iran in the first half of 2022, held a [hearing](#) on "State-Sanctioned Religious Freedom Violations and Coercion by Saudi Arabia and Iran," discussed the situation for religious prisoners of conscience in Iran on an episode of [USCIRF Spotlight Podcast](#), and published a report on [Religious Propaganda in Iran](#), in addition to highlighting the mandatory hijab law protests.

## **Film in Brussels about the institutionalized persecution of the Baha'is**

HRWF (01.11.2022) - On 26 October, Brussels Office of the Baha'i International Community (BIC) held the screening of a documentary by Farid Haerinejad, "Others in their own land", with the participation of the film producer himself. The event was hosted by a Member of the European Parliament, Leopoldo Lopez Gill (Political Group of Christian Democrats, Spain). Rachel Bayani introduced the event and both speakers on the name of the Brussels Office.

Farid Haerinejad retraced the history of the Iranian Revolution and the harsh persecution of the Baha'is since 1979 through the testimonies of numerous victims and survivors of the Ayatollahs' regime.

About 200 Baha'is were sentenced to death and executed in the first decade after the revolution for refusing to recant their faith, including women. Nowadays, the persecution is more insidious but not less brutal: no access to higher education and to jobs in public institutions, discrimination and stigmatization at school, dismissals from all sorts of professional activities, closure of shops held by Baha'is, confiscation or destruction of property, economic pressure, police crackdowns on private meetings, arbitrary arrests and fabricated charges, very high bails for a temporary release from pretrial detention, hundreds of people waiting for months and even years before going to prison, physical and psychological torture, etc.

The purpose of this anti-Baha'i policy is the suffocation of this faith community whose population is estimated at about 300,000 in Iran.

### **Christians**

**Converts cleared of wrongdoing in second trial on identical charges**

Article 18 (29.11.2022) - Three "Church of Iran" members serving five-year prison sentences for "spreading deviant beliefs contrary to Islam" have been cleared of wrongdoing in a second trial on identical charges.

Meanwhile, in a separate development, one of the men, **Morteza Mashoodkari**, has had his prison sentence reduced by half.

The second trial took place on 2 November at a Rasht Revolutionary Court. A week later, Morteza was informed that he had also been granted a "partial pardon" and reduction of his sentence to two and a half years.

### **USCIRF condemn's religious charges in Iran protester's death sentence**

Article 18 (16.11.2022) - The US Commission on International Religious Freedom has condemned the sentencing to death of an Iranian protester on "religiously-grounded charges" and warned of the "credible" threat of "large-scale executions in the coming weeks".

On Sunday, a Tehran Revolutionary Court sentenced the unnamed protester on charges including "enmity against God" and "corruption on Earth", which USCIRF noted were "both grounded in religious interpretations".

The independent, bipartisan group said the ongoing protests in Iran, now two months old, were at their root a cry for Iranians to be granted "their intentionally-guaranteed human rights", including religious freedom.

### **Defenders of Christians among over 30 lawyers arrested**

Article 18 (08.11.2022) - More than 30 lawyers, including at least three involved in defending Christian converts, have been arrested in recent weeks in cities across Iran.

The arrests come as thousands of protesters await trial, without recourse to legal advice, and amid calls from more than 200 Iranian MPs for them to be sentenced to death.

Hossein Ahmadiyaz, an Iranian human-rights defender now living in the Netherlands, told Article18 that many of the arrested lawyers are well-known figures, some of whom had offered legal advice to arrested protesters and openly "demanded the establishment of a legal commission to protect the rights of detainees, including the right of access to a lawyer".

### **'National security' charges deliberately vague 'to mislead public'**

Article 18 (07.12.2022) - Accusations that members of religious minorities, including Christians, are engaged in unspecified "actions against national security" are deliberately vague in order "to mislead the public", says the author of a recent report on religious propaganda in Iran.

The intention, according to Shahin Milani, executive director of the Iran Human Rights Documentation Center, is "to basically convince the masses, the public, that these individuals are engaging in nefarious actions against the Iranian state".

Mr Milani was speaking on Thursday, 3 November, as part of a virtual discussion hosted by the US Commission on International Religious Freedom (USCIRF), for whom his July report was written.

### **UK courts grapple with church leaders' expertise in assessing asylum-seekers' conversion claims**

Article 18 (04.11.2022) - The question of how much weight should be given to the testimony of church members and leaders in assessing the credibility of asylum-seekers' claims to have converted to Christianity has become pivotal in UK courts.

Guidance on this issue is included in the latest policy advice to the Home Office on how to assess the claims of Iranians who say they would be at risk if they were deported because they have become Christians.

The risk genuine converts – including ordinary church members, as well as leaders – would face upon return to Iran was accepted in previous guidance to the Home Office published in March 2020.

### **Iran using protests To further persecute Baha'is**

### **Baha'i citizen Parwa Behdad arrested**

### **Pressure on Baha'i citizen Payam Vali to make forced confession**

Iran Press Watch (10.11.2022) - According to a report received by "IranWire", Payam Vali, a Baha'i resident of Karaj, is under pressure and threats from the security agents to make a forced confession. He was told that he could be released only after he makes a confession. This Baha'i citizen is accused of propaganda against the regime by promoting the Baha'i religion, and propaganda against Islamic Sharia, communicating and cooperating with foreign media through interviews and sending news of human rights violations and inciting people to create protests through cyberspace.

### **Religious minority persecuted in Iran targeted with sophisticated Android spyware**

Iran Press Watch (03.11.2022) - Kaspersky is warning of a previously unknown espionage campaign targeting the Persian-speaking religious minority Baha'i with Android spyware.

As part of the campaign, victims were lured to a VPN application claiming to provide access to Baha'i religious resources that are banned in Iran.

The application contains highly sophisticated spyware designed to collect all types of data from devices, including call logs and contact lists, and to track victims' activities. The malware, named SandStrike, also supports commands that allow the attackers to perform various operations on the device.

### **Iran arrests Baha'i in continuing crackdown on faith**

#### Iran punishes Christians with harsh prison sentences

Evangelical focus (19.10.2022) - When authorities in Iran summoned a Christian couple in Tehran on August 13, the house-church members supposed it concerned the return of their confiscated belongings.

Instead, **Homayoun Zhavesh** and his wife **Sara Ahmadi** were detained in Tehran's Evin Prison, notorious for its harsh treatment of people deemed political enemies of the state, rights organizations say.

"Friends are concerned about their well-being, especially as Homayoun suffers from advanced Parkinson's disease", Christian Solidarity International (CSI) said in an October 6 statement, citing information from Middle East Concern.

#### Iranian Christians join protests over woman's beating death: Reports

Washingtontimes.com - Five weeks of street protests in Iran have attracted and emboldened the Islamic republic's Christian minority, human rights advocates said Thursday.

More than 300 Iranian Christians took the unusual step of releasing a public letter protesting the regime as a "bloodthirsty infection" on the nation, Lela Gilbert, senior fellow for international religious freedom at the Family Research Council, told a webinar sponsored by the group Save the Persecuted Christians.

Ms. Gilbert said Christian believers are stepping forward to join protests over the treatment of Mahsa Amini, a 22-year-old Kurdish-Iranian woman, who died last month in the custody of Iran's "morality police" after being detained for reportedly wearing the mandatory headscarf incorrectly in public.

Ms. Gilbert said the protest letter "is the first time the Christian community, not just women, men and women, has made a statement against the regime." She estimates that "at least a million Christians" in Iran have converted from Islam, although others believe the number is far greater.

### Iran: Christian convert released from prison

Middle East Concern (18.10.2022) - Iranian Christians are rejoicing that **Naser Navard** Goltapeh was released from Evin Prison on 17 October after being pardoned by the Supreme Leader, Ali Khamanei.

The Iranian pastor was arrested along with three Azerbaijani Christians in June 2016. In June 2017, they were each sentenced to 10 years' imprisonment for "acting against national security through forming and establishing illegal house churches." The Azerbaijanis had left Iran during the process, forfeiting bail. Naser was taken to Evin prison in January 2018 after his conviction and sentence were upheld by the appeal court.

Naser repeatedly requested leave and early release which was consistently denied. His release now as part of the pardon of several people, came as a surprise. There has been concern for the Christians detained in Evin during the recent fire and reported shots and explosions (state media reports eight prisoners were killed). It has been a relief that most Christians have been able to contact family and assure them that they are okay

### Arrest of a Baha'i Couple in Kerman

Iran Press Watch (28.10.2022) - **Shagaig Bahrami and Shayan Gholami**, a Baha'i couple living in Kerman, were arrested by the security forces on Monday, October 24, and taken to the city's intelligence department. The security forces searched the houses of these citizens at the time of their arrest.

An informed source about the situation of these citizens told Harana: "After the arrest, this Baha'i couple was transferred to the detention center of the Kerman Intelligence

Department. The follow-up of the families regarding the situation of these citizens has been unsuccessful so far.”

During the arrest, while searching the house, the officers seized some of the personal belongings of these citizens and took them with them.

### **Milad Sanai, Baha’i citizen, arrested in Sari**

Iran Press Watch (28.10.22) - According to Harana news agency, the news organ of the group of human rights activists in Iran, on Tuesday, October 25, 2022, **Milad Sanai**, a Baha’i citizen, was arrested in Sari.

An informed source told Harana: “Sari intelligence agents arrested Mr. Senai outside his house. They then performed an inspection of his home, during which they confiscated Mr. Senai’s mobile phone and laptop. According to some knowledgeable sources, security officers cited protest activity in cyberspace as the reason for his arrest.

To-date there is no information about the whereabouts of this citizen.

### **Baha’i Individual Leili Karami Arrested in Shiraz**

Iran Press Watch (27.10.2022) - On October 26, 2022, security forces arrested Baha’i citizen **Leily Karami** at her house in Shiraz and transferred her to a detention facility known as House No 100. The agents searched her home and confiscated some of her personal belongings.

According to HRANA, the news agency of Human Rights Activists, Baha’i citizen Leily Karami was arrested at her house in Shiraz.

The reason for her arrest and the charge is still unknown.

### **Baha’is arrested for instigating “sedition” and protests**

Iran Press Watch (18.10.2022) - The Baha’i faith, one of the world’s youngest religions, was founded in Iran in the nineteenth century, but its followers have long faced persecution in the country, especially since the establishment of the Islamic Republic. Dozens have been arrested, imprisoned and attacked. As recently as July, several preschool teachers were detained in a series of raids by intelligence officers. They were accused of being spies.

“Iran’s government has for more than 40 years alleged that Bahá’ís are spies for foreign countries but, in all that time, has failed to produce a shred of credible evidence,” said Diane Ala’i, representative of the Baha’i International Community to the United Nations. “Now they are reduced to attacking kindergarten and daycare teachers as a threat to national security.”

### **Iran intensified crackdown against Baha’i religious minority**

Iran Press Watch (17.10.22) - Iranian officials have intensified a crackdown against members of the Baha'i minority amid ongoing unrest across Iran.

According to the information received by IranWire, **Badie Khazei**, 31, a Baha'i citizen, was stopped by intelligence agents when he and some of his friends were out for dinner in Tehran.

Authorities in Fashafuye prison separated him from other prisoners and transferred him to Evin prison after learning about Badie Khadei's religious beliefs.

Iranian officials have arrested at least five members of the Baha'i minority over the recent days.

The Baha'i minority in Iran is among the parts of the Iranian society that have been in the spotlight of government pressures and confrontations since the beginning of the Islamic system in Iran.

### **The Arrest of Saman Khadem, Baha'i citizen and environmental activist in Shiraz**

It should be mentioned that Saman Khadem has been active in the field of photography and environment.

Simultaneously with nationwide protests in Iran, many Baha'is have been arrested in different cities of Iran.

### **Baha'is citizen Aida Rasti arrested 13 days after release from prison**

Iran Press Watch (12.10.2022) - On September 28, 2022, security forces arrested Baha'is citizen **Aida Rasti** at her house and took her to Ward 209 of Evin Prison. During the arrest, the agents searched her home and confiscated some of her personal belongings.

According to HRANA, the news agency of Human Rights Activists, on September 28, 2022, Baha'is citizen Aida Rasti was arrested by security forces.

An informed source close to her family told HRANA that she was arrested again just 13 days after release from prison. According to this source, Rasti has been denied access to her lawyer and family visitation. The judicial and prison officials have unanswered her family's frequent enquire.

The reason for this arrest and the charges are still unknown.

### **Baha'is citizen Enayatollah Naeimi arrested**

Iran Press Watch (03.10.2022) - Last Wednesday, September 28, security forces arrested Baha'is citizen **Enayatollah Naeimi** in Isfahan. The agents searched his house, workplace and garden in the Isfahan suburbs. Enayatollah is a brother of Afif Neimi who was a member of a now-disbanded Baha'i group known as the "Yaran e Iran" or "Friends of Iran," which addressed the spiritual and social needs of the Baha'i community.

According to HRANA, the news agency of Human Rights Activists, on September 28, 2022, the intelligence agents arrested Baha'is citizen Enayatollah Naeimi in Isfahan. An informed source told HRANA that Naeimi underwent surgery last year and is now in poor health condition, making him hard to endure jail.

On July 31, 2022, three other members of the "Yaran e Iran" Afif Naeimi, Mahvash Sabet and Fariba Kamal Abadi were arrested.

## Iran punishes Christians with harsh prison sentences

*Many Christians arrested and charged for belonging to "illegal" groups.*

Evangelical Focus (19.10.2022) - <https://bit.ly/3su16YB> - **When authorities in Iran summoned a Christian couple in Tehran on August 13, the house-church members supposed it concerned the return of their confiscated belongings. Instead, Homayoun Zhaveh and his wife Sara Ahmadi were detained in Tehran's Evin Prison**, notorious for its harsh treatment of people deemed political enemies of the state, rights organizations say.

"Friends are concerned about their well-being, especially as **Homayoun suffers from advanced Parkinson's disease**", Christian Solidarity International (CSI) said in an October 6 statement, citing information from Middle East Concern.

CSI and other advocacy and aid organizations recently issued calls for prayer for Zhaveh, 63, and Ahmadi, 44.

**Middle East Concern (MEC) reported they were first arrested in June 2019 on suspicion of belonging to an "illegal organization"**, with Zhaveh spending a month in Evin Prison and Ahmadi held there for 67 days – half the time in solitary confinement.

**In November 2020, Ahmadi was sentenced to 11 years in prison for her alleged role in leading a house church**, according to MEC, adding that **Zhaveh** was sentenced to **two years for house church membership**.

The sentences included a **two-year ban on membership in any social or political group**, a two-year ban **on foreign travel** and six months of community service.

The convictions were upheld on appeal in December 2020, but **Ahmadi's prison sentence was reduced to eight years**, MEC reported.

The couple expected to start their prison sentences on June 15, 2021, but upon arrival at Evin Prison in the midst of the COVID-19 pandemic, they were told they could return home for an indeterminate time.

“On August 13, Homayoun and Sara answered a summons to the prison, expecting to have confiscated property returned,” MEC stated. “Instead, they were both detained.

**Prayer is requested that their harsh sentences will be reviewed**, especially since Homayoun is in poor health, and that they will be acquitted; and that the Iranian authorities will stop the persecution of their citizens for the peaceful expression of their faith.”

### ***Rash of imprisonments***

Also serving time in Evin Prison for his faith is **house-church leader Joseph Shahbazian, sentenced to 10 years** by Branch 26 of the Tehran Revolutionary Court on June 7 **for “founding and leading an organization that aims to disrupt national security”**, according to the U.S. Commission on International Religious Freedom (USCIRF).

Initially arrested on June 30, 2020, following raids on house churches in several cities, Pastor Shahbazian **was released on bail** on August 22 of that year.

An appeals **court in Tehran rejected his appeal** in August of this year, and on August 30 he began serving his sentence at Evin Prison, USCIRF reported.

As an Iranian-Armenian **he was permitted to worship as part of Iran’s historic Armenian Christian community, but he was targeted as a pastor** of a church that included Iran converts from Islam, according to Barnabas Fund.

In the Shiite stronghold of Mashad in northeastern Iran, **a grandfather with cancer is being held in Vakilabad Prison for converting to Christianity**, according to advocacy group *Article 18*.

Gholamreza Keyvanmanesh, in his late 50s, and **three other Christians arrested in Neyshabur face charges of “acting against national security** through propaganda against the regime” and “insulting the sacred” (blasphemy), *Article 18* reported.

“The other three – **two women and another man**, in their 40s and 50s, whose names cannot be reported – **are being held** in Neyshabur Prison,” the organization stated.

Members of the Islamic Revolutionary Guard Corps warned at least eight other Christians present at the meetings of the four arrested Christians that they will soon be summoned for further questioning, according to *Article 18*.

“They were also **forced to sign commitments to refrain from gathering with other Christians**”, *Article 18* reported. “Bibles and mobile phones were among the items confiscated from the church members.”

Christianity is among the official minority faiths in Iran, but **converts to Christianity are not recognized and are vilified as “enemy groups of a ‘Zionist’ cult,”** the group stated.

Converts are banned from attending the churches of Armenian and Assyrian Christians, who are permitted to teach only in their own ethnic tongues and not to seek new members, *Article 18* stated.

Hence **converts meet at private homes but are frequently raided and charged with belonging to “illegal” groups** with “anti-security” purposes, “even though in reality the meetings are no different from church gatherings anywhere else in the world”, *Article 18* stated.

“In recent years, dozens of Iranian Christians have been handed prison sentences of up to 15 years on such trumped-up charges.”

Iran was **ranked 9th on Open Doors’ 2022 World Watch List** of the countries where it is most difficult to be a Christian.

#### **Iranians are ready for a different approach to religion and government**

FiveThirtyEight (30.09.2022) - Protests in Iran have been raging on for nearly two weeks because 22-year-old Mahsa Amini died in the custody of the “morality police” after she allegedly failed to comply with the nation’s veiling laws. The protests that began on the streets of Saqqez, her hometown, have now spread to roughly 80 cities across the nation, as Iranian women lead demonstrations in defiance of a law that mandates they cover their hair and wear loose-fitting clothes while in public. At least 76 people have died, although the toll is likely higher as internet restrictions have made information harder to confirm.

#### **UN experts strongly condemn death of Mahsa Amini**

"She is another victim of Iran's sustained repression and systematic discrimination against women and the imposition of discriminatory dress codes that deprive women of bodily autonomy and the freedoms of opinion, expression and belief", the experts added

### **Dissident: 'Iranian women are furious' over headscarf death**

Apnews (24.09.2022) The tears come quickly to Masih Alinejad when she talks about the messages she's received in recent days from women in Iran protesting against their government after a young woman died in police custody over a violation of the country's strict religious dress code.

They talk about the risks, possibly fatal ones, in facing off against government forces that have a long history of cracking down on dissent. They share stories of saying goodbye to their parents, possibly for the last time. They send videos of confrontations with police, of women removing their state-mandated head coverings and cutting their hair.

According to a tally by The Associated Press, at least 11 people have been killed since protests began earlier this month after the funeral of 22-year-old Mahsa Amini, who died in custody after being detained by Iran's morality police. State media has said the toll could be as high as 35.

### **Payam Vali and Sepehr Ziaei, Baha'i Citizens, arrested**

Iran Press Watch (26.09.2022) - Two Baha'i citizens were arrested by the security forces on Saturday, September 24, 2022, and taken to an unknown location. **Sepehr Ziaei** was arrested at his home in Tehran. **Payam Vali** was arrested in Karaj at his business. Both Mr. Vali and his son, Adib Vali, were beaten by the officers.

A well-known source told Harana: "Yesterday, eight forces of the Ministry of Intelligence went to Payam Vali's workplace in Karaj and tried to detain this Baha'i citizen by beating him. Then the security forces searched his house, and in the meantime Adib, Mr. Vali's son, was also beaten by the security forces. The officers confiscated a number of Adib Vali's personal devices, including his mobile phone and laptop and took them with them.

### **'The World is watching': Australian daughter of Iranian Baha'i in prison pleads for her release**

Iran Press Watch (16.09.2022) - When Negar Sabet awakes after a restless night in Sydney, she agonises about her elderly mother, Mahvash Sabet, who has been locked up in Iran's notorious Evin prison since the end of July.

"She's in solitary confinement, again, with just a piece of cloth," Negar tells ABC News. It's not the first time her mother, who is a teacher, writer and poet, has been arrested – that was in 2005, on the day of Negar's wedding.

That time, Ms Sabet was released after questioning but in 2008, she spent 10 years in prison.

This time, Negar is conscious of the stories her mother has told about prison, but she doesn't want to imagine how her mother is being treated.

"This is 2022 and the world is watching," she says.

"They cannot simply torture a woman. Do they have no respect for such a thing as a woman, elderly, [who] already spent [time] in jail, and [is] sick?"

### **Baha'is citizen Jila Shahriari imprisoned**

Iran Press Watch (14.09.22) - According to HRANA, the news agency of Human Rights Activists, Baha'i citizen Jila Shahriari started her sentencing at Evin Prison.

An informed source told HRANA that Evin Prison officials called Shahriari to appear at Prosecutor's Office to answer questions, but she was taken in.

In September 2016, intelligence agents arrested Shahriari at her house in Tehran. She was released on bail after 31 days of interrogation.

The Tehran Revolutionary Court later sentenced her to five years imprisonment. This sentence was reduced to two years and six months on appeal.

### **Hollywood actors condemn Iran's persecution of Baha'is**

Iran Press Watch (12.09.2022) - Three Hollywood actors and celebrities, Mark Ruffalo, Rainn Wilson and Justin Baldoni, have denounced the Iranian government's ongoing persecution of the Baha'i community in a series of tweets published last week. The interventions came after security agents arrested 13 young Baha'is in the city of Ghaemshahr in Iran's Mazandaran province.

No charges against the young Baha'is have been announced.

"This is very disturbing news and the international community should be aware of this," Ruffalo tweeted to his 8.2 million followers, sharing the latest news release published by

the Baha'i International Community (BIC) last week. His tweet was shared nearly 300 times as of Monday and liked more than a thousand times.

Rainn Wilson called the situation "shameful", in a post to his 4.4 million followers, and using the #freeBahaiyouth hashtag that had emerged online, and said that the Iranian authorities were "criminalising" Baha'i citizens. And Justin Baldoni asked his followers to retweet the news and said it was "unbelievable that this is still happening".

Thousands of other tweets by Iranian activists and citizens, as well as many supporters around the world, also shared the latest news and expressed support for the human rights of the Iranian Baha'i community.

### **Baha'i individual Fariba Ashtari arrested in Yazd**

Iran Press Watch (10.09.2022) - An informed source told HRANA that Ashtari has been arrested to start her five-year sentence. She had a heart disease for which she had undergone surgery two times last year.

On December 2, 2019, the intelligence agents arrested Ashtari at her house and on February 2019, she was released on bail.

On June 20, 2020, the Revolutionary Court of Yazd sentenced Ashtari to five years on the charge of "membership in an anti-regime group" and one year in prison on the charge of "propaganda against the regime". Based on Article 134 of the Islamic Penal Code, five years imprisonment for the first charge is enforceable to her.

Previously, Ashtari and her husband and son had also faced arrests and convictions. Between 2014 to 2016, she had been imprisoned in Yazd Prison. Her husband, Naser Bagheri was imprisoned for nine months. Her Son, Faez Bagheri was arrested in March of 2015, when he was 17 years old. He was released on bail after five months. Later, he was sentenced to three years in prison but the verdict was commuted to a one-million-toman fine on appeal.

### **Iran's Government cracks down on Baha'is; 200 incidents reported**

Iran Press Watch (05.09.22) - The Iranian government cracked down on the Baha'i religious minority over a three-week period starting on July 31. There were 200 reported incidents, according to the Bahá'í International Community (BIC), the official voice of the Bahá'í community, responsible for the defense of the Bahá'ís in Iran. BIC also reports its findings to the United Nations.

According to BIC, actions by Iranian officials included: arbitrary arrests; imprisonment; destruction and confiscation of property; and denying Bahá'í youth access to higher education and universities. More than 100 Bahá'ís were arrested during the crackdown.

### **25 Baha'is sentenced to prison in Shiraz**

Sens Daily (03.09.2022) - The Provincial Review Court for Shiraz has sentenced 25 Baha'is there to prison terms. It handed down 5-year sentences to **Yekta Fahandezh-Sa`adi, Laala Saalehi, Bahaareh Nowruzi, Rezvan Yazdani and Mozhgaan Gholampour**. Their passports are revoked for two years — presumably after the

completion of their sentences — during which time they are required to report daily to the Provincial office of the Ministry of Intelligence.

Five-year sentences and a two-year passport confiscation were also given to **Nabil Tahdhib, Sahba Maslah, Behnaam Azizpour, Esma`il Rusta, Ramin Shirvaani and Sa`id Hassani**. These five were also sentenced to internal exile in other provinces: Mr. Tahdhib to Izeh, in Khuzestan Province, Sahba Maslahi to Ferdows in South Khuzestan, Behnaam Azizpour to Dehdasht, Esma`il Rusta to Baft in Yazd Province, Ramin Shirvaani to Bagh-e Malek in Khuzestan, and Sa`id Hassani in Lordegan, in Chaharmahal and Bakhtiari Province, where they would be required to report daily to the Ministry of Intelligence.

### **Fourteen young Baha'is arrested in Qaemshahr**

Sens Daily (02.09.2022) - During the afternoon of 31 August, agents of the Ministry of Intelligence in Mazandaran province raided the home of a Bahai, Mojir Samimi, in Qaemshahr, and arrested eleven young Bahais from Qaemshahr, Sari and Babolsar during a religious study meeting. The Baha'is were reading prayers and religious books.

Officers also arrested Afnaneh Nematian, Mojir's mother, and transferred all twelve people to the Sari Intelligence Department.

"Officers went to the house of one of the detainees, named Bita Haqiqi, and searched this house without showing the warrant," an informed source told IranWire. "And another group of security agents stormed the home of two other Bahais in Qaemshahr, Golban Fallah and Sanaz Hekmat Shaar, and searched their homes, without showing a warrant, and confiscated books and works related to the Bahai faith. Both of them were also arrested."

The informed person further said that, after following up, families of the detainees found out that all fourteen were transferred to the detention center of the Sari Intelligence Department. Two of the families managed to meet with one of the people responsible for their children's detention. The officer told them that if their children cooperated, they would be released, but that if they did not then they would continue to be detained.

The names of the fourteen arrested Bahais are **Afnaneh Nematian, Mojir Samimi, Samia Qolinejad, Basir Samimi, Mehsa Fathi, Negar Darabi, Hengeme Alipour, Mani Qolinejad, Nazanin Goli, Sam Samimi, Sanaz Hikmat Shaar, Bita Haghghi and Anis Sanai**.

## **News about Baha'is and Christians in Iran in August**

### **Baha'is**

**Sepideh Rashno was released on an 800-million-tomans bail after being indicted.**

Hrana (30.08.22) - According to #HRANA, the news agency of Human Rights Activists, artist **Sepideh Rashno** was indicted and then released on bail until the end of the legal proceeding.

On August 29, Branch 26 of the Tehran Revolutionary Court indicted Rashno on the charge of "assembly and collusion to act against national security", "propaganda against the regime", and "promotion of impurity and indecency."

On July 16, security forces arrested Rashno after a quarrel on a city bus with a woman who harassed and assaulted her for what she deemed as improper hejab. Such incidents are on the rise in public places as the government has tightened the hejab enforcement.

On July 30, Official media outlets inside Iran released a forced confession video of Rashno. HRANA revealed that prior to this confession, Rashno had been hospitalized due to the risk of internal bleeding indicating she had been tortured to make the confession.

Rashno, age 28, is a student of Tehran University and a resident of Khorramabad.

### **Bahiyyeh Manavipour bailed in Shiraz**

Sens's daily (27.08.2022) - **Bahiyyeh Manavipour** has been released on bail. She is one of five young Baha'is arrested by agents from the Ministry of Intelligence on July 19. They were taken to the Ministry of Intelligence's "Facility 100" for interrogation. Their homes were searched at the time of their arrest. The charges against her are not yet known.

### **Prejudiced courts aiding land grabs of Baha'i properties in Iran**

Center for human rights in Iran (24.08.2022) - An ongoing campaign of religious persecution by the Iranian government has so far resulted in more than 1,000 members of the Baha'i minority faith awaiting jail sentence announcements, confiscation of Baha'i-owned lands and properties, raids on dozens of Baha'i homes, as well as the destruction of Baha'i properties.

More than 60 Baha'is have meanwhile been banned from attending university despite passing the country's prequalifying and highly competitive national entrance exams.

### **Stop ruthless attacks on persecuted Baha'i religious minority**

Amnesty (24.08.22) - The Iranian authorities' persecution of the Baha'i religious minority has increased in intensity with a recent flurry of raids, arbitrary arrests, home demolitions and land grabs, Amnesty International said today.

Since 31 July 2022, Ministry of Intelligence agents have raided and confiscated dozens of Baha'i properties and arrested at least 30 members of the Baha'i community on account of their faith in various cities throughout Iran. The authorities have subjected many more to interrogations and/or forced them to wear electronic ankle bracelets. The Ministry of Intelligence announced on 1 August that those arrested were "core members of Baha'i espionage party" who "propagated Baha'i teachings" and "sought to infiltrate various levels of the educational sector across the country, especially kindergartens".

### **Baha'is expose 'Propaganda ploy' to incriminate community with fake videos and hate speech**

Iran Press Watch (22.08.2022) - The Baha'i International Community (BIC) today reported news of an effort to incriminate the Baha'is in Iran through a staged video

production, filmed in a kindergarten, designed to produce propaganda footage that would show Baha'is teaching their religion in educational establishments.

On 31 July, according to the latest BIC statement, and the same day that intelligence agents were invading Baha'i homes and arresting pre-school teachers, agents also entered a kindergarten in a major city in Iran and distributed Baha'i books and pamphlets to its teachers, none of whom were Baha'is. The agents reportedly instructed and forced the kindergarten staff to say, on camera, that Baha'is had brought these materials and distributed them to the teachers.

### **At least 90 Iranians of Baha'i faith denied university this year**

Iran Press Watch (22.08.2022) - Informed sources tell Iran International that at least 90 Iranian Baha'i students have been barred from universities this year due to a secret government policy.

The United States-based Human Rights Activists' News Agency (HRANA) reported Thursday that so far it has identified 62 Baha'i students who took the university entrance examination this year and were rejected for their faith.

### **Home raid in Qazvin**

Hrana / Sens Daily (14.08.22) - On August 9, security agents raided the home of **Gulriz Nouraani** and **Mehrzaad Zahraa'i**, a Baha'i couple living in Qazvin. They seized digital devices, books and works related to the Bahai Faith, a gold ring with religious motifs, and some of their personal pictures. Mr. Zahraa'i was not home, and the agents did not have a female officer with them.

### **Hanaan Haashemi pressured for a "confession"**

Sens Daily (11.08.2022) - **Hanaan Haashemi**, who was arrested in Shiraz on July 19 and is held by the Ministry of Intelligence, has informed her family in a telephone call that she is under pressure from interrogators to make a forced confession. It is not known what she is supposed to confess to, or why she was arrested, apart from her Baha'i beliefs. Interrogators have told her that her release from prison will only happen if she makes a confession as they instruct.

On July 19, 2022, security forces arrested her with four other Bahai's: **Nilufar Hosseini**, **Bahiyyeh Manavipour**, **Mithaaq Manavipour** and **Elhan Haashemi**. Nilufar Hosseini and Elhan Haashemi have been released on bail.

### **Treatment of Baha'i in Iran: FCDO minister's statement**

Gov.UK (05.08.2022) - The UK is deeply concerned by increasing arrests of the Baha'i in Iran, including recent reports that the Iranian government has demolished houses and confiscated land in Roushankouh, Iran. Former spiritual leaders of the Baha'i in Iran are also reported to have been detained.

FCDO Minister responsible for Human Rights and Freedom of Religion and Belief, Lord (Tariq) Ahmad of Wimbledon, said:

The persecution of religious minorities cannot be tolerated in 2022. We strongly condemn the increasing detention of members of the Baha'i community in Iran, as well as reports

of forced closures of their businesses and land seizures. The persecution of religious minorities is a serious violation of international human rights law. We are working closely with our international partners to hold Iran to account and continue to raise human rights concerns regularly with the Iranian government.

### **UN should condemn renewed crackdown on persecuted Baha'i faith in Iran**

Center for human rights in Iran (05.08.2022) - Increasing arbitrary arrests of members of the persecuted Baha'i faith in Iran, and an intensifying government-sponsored campaign of destruction and confiscation of their properties should be internationally condemned, said the Center for Human Rights in Iran (CHRI).

Ahmed Shaheed, the UN Special Rapporteur on freedom of religion or belief, should demand accountability for the state's ruthless and systematic persecution of the minority religion.

### **Spain: a letter to the Iranian ambassador about the case of four sentenced Christians**

Aricle 18 (01.08.2022) - The Spanish Evangelical Alliance (AEE) has sent a letter to the Iranian embassy in Spain regarding the case of four Christians who have recently been sentenced to prison terms in the Persian country.

The document, signed by the organisation's secretary general, Emilio Carmona, sets out the cause of the four believers in question.

"These people were simply exercising their freedom of thought, conscience and religion, as well as their freedom of expression, as defined in the International Covenant on Civil and Political Rights ratified by their country". Carmona adds: "I am deeply shocked by this news because I believe that freedom of religion or belief is very important".

Moreover, the document expresses clear concern not only for the situation of the sentenced believers, but also for that of Christians in Iran as a whole.

### **A couple of converts under threat of deportation from Belgium**

HRWF (23.08.2022) - **Hamid Reza Hossein Khani** (42) and **Mariam Soltani** (38), two converts from Shia Islam to Protestantism, have recently been denied asylum by the Belgian authorities and are under threat of being sent back to Iran where they are at risk of being arrested and sentenced to a prison term for apostasy.

They converted to Christianity about three years ago and are now attending a Protestant Church in Belgium (the United Protestant Church of Belgium recognized by the state). They run a website in Farsi language (<http://www.lightsindarkness.com>) through which they spread the message of the Bible to their fellow citizens in Iran and the diaspora. Their website enjoys such an audience that VOA News has mentioned it in one of its programs in Farsi.

## **Malihe Nazari, Joseph Shahbazian and Mina Khajavi**

Article 18 (17.08.2022) - Joseph, Mina and Malihe were among at least 35 Christians arrested or interrogated by intelligence agents belonging to Iran's Revolutionary Guard in a coordinated operation over two days and across three cities in the summer of 2020.

The arrests took place on the evening of 30 June and the morning of 1 July in Tehran, its sister city Karaj, and Malayer, 400km southwest of Tehran.

Dozens more Christians were ordered to provide their contact details and told they would soon be summoned for questioning.

The first arrests took place at around 8pm on the evening of 30 June, in western Tehran's Yaftabad district.

## **Christians lose appeal against imprisonment and fines for house-church activities**

Article 18 (17.08.2022) - An Iranian court of appeal has upheld the sentences of five Christians facing a total of 22 years in prison and the equivalent of \$2,225 in fines for their involvement in house-churches.

**Joseph Shahbazian**, 58, a "recognised" Christian of Armenian descent, faces 10 years in prison, and Christian converts **Mina Khajavi**, 59, and **Malihe Nazari**, 48, six years.

Meanwhile, mother and daughter Masoumeh Ghasemi and Somayeh (Sonya) Sadegh, who are also converts, must pay fines of 24 million (\$950) and 40 million (\$1,275) tomans respectively.

## **Germany denies refuge to Christian convert – after family member tortured, killed for his faith**

Adf international (11.08.2022) - A 44-year-old Iranian cabinetmaker who converted to Christianity has been denied protection in Europe, facing likely imprisonment or death upon return to his home country. The European Court of Human Rights has dismissed his attempt to appeal the decision on the basis of his right to freedom of religion. The 44-year-old is now threatened with deportation to Iran.

"No one should be persecuted for their faith. Iran is one of the most dangerous countries in the world for Christians, and converts are particularly at risk. In the last year, religious persecution has greatly worsened. So-called "religious deviants" can be given prison sentences, national security charges are continuously used to target religious minorities. The courts in Germany must take this into account when processing asylum applications," said Lidia Rieder, Legal Officer at ADF International

## **Iranian Christian converts struggle to get asylum in Germany**

Evangelical focus (05.08.2022) - According to human rights activists, asylum applications by Iranians who have converted to Christianity have less and less chance of success in Germany.

"Human rights violations on religious grounds are an everyday reality in the country", said Martin Lessenthin, board spokesman of the International Society for Human Rights (IGFM), in a press conference about the situation of Christian converts from Iran in Germany.

At the IGFM's press conference, pastor Gottfried Martens called the Federal Office for Migration and Refugees (BAMF) "a political authority that is not concerned with the individual case of an asylum application".

### **Supreme Court denies Christians retrial**

Article 18 (03.08.2022) - Three Iranian Christians have been informed that the Supreme Court has refused to review their sentences of prison and exile for "propaganda contrary to and disturbing to the holy religion of Islam".

Anooshavan Avedian, a 60-year-old Iranian-Armenian, faces 10 years in prison, while Christian converts Abbas Soori and Maryam Mohammadi, who are both in their mid-forties, must spend two years in internal exile, outside their home province of Tehran or any adjacent provinces.

HRWF (23.08.2022) - Hamid Reza Hossein Khani (42) and Mariam Soltani (38), two converts from Shia Islam to Protestantism, have recently been denied asylum by the Belgian authorities and are under threat of being sent back to Iran where they are at risk of being arrested and sentenced to a prison term for apostasy.

They converted to Christianity about three years ago and are now attending a Protestant Church in Belgium (the United Protestant Church of Belgium recognized by the state). They run a website in Farsi language (<http://www.lightsindarkness.com>) through which they spread the message of the Bible to their fellow citizens in Iran and the diaspora. Their website enjoys such an audience that [VOA News](#) has mentioned it in one of its programs in Farsi.

These Iranian converts were born and living in Qom, a city in Iran well-known for its university training radical Iranian and foreign Shia imams. Some of them from Azerbaijan who were educated in Qom were put in prison for extremism when they went back to their country.

I personally interviewed the couple of converts for two hours on 19 May 2022.

### **Hamid Reza Hossein Khani**

Hamid graduated from the Islamic Azad University of Qom as a teacher of English language and literature. He speaks Farsi, English and can manage it in Turkish.

Until he fled from Iran in 2020, he had been teaching English. In the year 1397 (2018), one of his students who happened to be a Christian shared his faith with him during several months and invited him to watch videos from YouTube about the Christian faith.

Hamid participated in house church meetings and in June 2019, he converted to Christianity. The religious meetings were taking place in different houses and convened about 6-7 converts in all.

In summer 2020, their meeting, which was taking place in Hamid's house, was interrupted by 'a visit' of intelligence services agents in civilian clothes. Hamid and Mariam managed to flee but other believers were arrested.

Some days later, Hamid and Mariam fled Iran in fear of being arrested and imprisoned.

Hamid has a 11year old daughter

They arrived in Belgium in September 2020.

### **Mariam Soltani**

Mariam comes from a pious Shia family. Her grandfather was a mollah.

She had a beauty salon in Qom. Through a Romanian client who happened to be in Iran, she was put in contact with the leader of a house church in 2019. She met Hamid at one of the house church meetings in the same year. There were some links between their own families and they knew each other.

Mariam has three children: two daughters (13 and 8 years) and one son (18 years)

Mariam's relatives and neighbors know that she has fled abroad and about her conversion and it seems the police are actively hunting her.

### **Persecution of Christians in Iran**

HRWF has a worldwide database of religious prisoners belonging to 19 religious groups in 18 countries. In Iran, HRWF has documented 14 cases of Protestants, mainly converts, who are behind bars <https://hrwf.eu/hrwf-prisoners-database-other-countires/>

### **Opinion and conclusion**

After interrogating the two asylum-seekers for two hours, including about their conversion, my conclusions are that

- Hamid and Mariam really converted to Christianity in Iran
- They could have been arrested there at any time
- Mariam Soltani could be killed by her uncle, an Islamic hardliner, if sent back to Iran
- Hamid and Mariam are true Protestant believers who continue to actively participate in religious life in Belgium
- They should be granted political asylum.

## **Germany denies refuge to Christian convert – after family member tortured, killed for his faith**

***An Iranian Christian convert in Germany faces likely death for his faith as deportation looms***

***Court deems it “unlikely” that a person would have really converted to Christianity after family member was killed for his beliefs***

**ADF International** (11.08.2022)- <https://bit.ly/3dAYd48> – A 44-year-old Iranian cabinetmaker who converted to Christianity has been denied protection in Europe, facing likely imprisonment or death upon return to his home country. The European Court of Human Rights has dismissed his attempt to appeal the decision on the basis of his right to freedom of religion. The 44-year-old is now threatened with deportation to Iran.

“No one should be persecuted for their faith. Iran is one of the most dangerous countries in the world for Christians, and converts are particularly at risk. In the last year, religious persecution has greatly worsened. So-called “religious deviants” can be given prison sentences, national security charges are continuously used to target religious minorities. The courts in Germany must take this into account when processing asylum applications,” said Lidia Rieder, Legal Officer at ADF International.

### ***A dangerous journey to Christianity***

Hassan – whose name has been changed to protect his identity and is recorded only as “H.H” in public documents – applied for asylum in 2018.

He testified before the Federal Office for Migration and Refugees that he had learned about Christianity in Iran through his wife’s brother. His brother-in-law had been imprisoned for his activities with a house-church, and was ultimately killed for practicing his faith in jail.

“My wife’s brother had become a different person by becoming a Christian. We wanted to see if we would get this feeling when we became Christians,” H.H. told the authorities.

“I had had many problems in Iran...I had many questions, but I was not allowed to ask them. When I asked questions, I was beaten at school. This led me to want to know which God I was facing. One day my brother-in-law said to me and my wife that he had good news. There is a treasure, there is a living God, Jesus Christ, we are His children and not His slaves...He said there is a free salvation available,” he continued, reflecting on his conversion experience.

Subsequently, Hassan’s wife adopted the Christian faith and eventually the whole family converted. Once discovered, security forces then stormed their

house and confiscated books, the computer, their passports and their Bible. The family fled to Turkey, and from there to Germany.

"In Germany I share the gospel, I organize prayer circles here in the accommodation. I want to be a good example, to win the others to faith in Jesus Christ. My greatest goal would be for my children to be able to find Christ in freedom, and to do good," said Hassan.

### ***Credibility under Question***

When H.H.'s asylum application was rejected by German authorities, he appealed to the Greifswald Administrative Court. The court dismissed H.H.'s case, declaring that it was "not particularly likely" that a Muslim would decide to become a Christian after his brother-in-law had been tortured and killed and his wife abused. It was more likely that the events described, if they had actually taken place, would have a deterrent effect on third parties," said the Administrative Court.

"There are national and international guidelines for asylum applications based on religious grounds. According to the United Nations High Commissioner for Refugees (UNHCR), decision-makers need to be objective and not arrive at conclusions based solely upon their own experiences. General assumptions about a certain religion or country should be avoided. Unfortunately, this guidance is being used very selectively by the German decision-makers. They do not understand that maintaining a religious belief when persecuted can be appealing to others and not just a deterrent as seen from the history of Christianity," Rieder continued.

This week, the European Court of Human Rights quickly declined to hear arguments in Hassan's defense, leaving him vulnerable to deportation to a country where religious conversion can carry a prison penalty.

### ***Inconsistent allocation of asylum decisions nationwide***

According to OpenDoors, Iranian asylum seekers in Germany are often confronted with suspicions of feigned conversion. The situation varies greatly across the country: a comparison of the federal states shows an inconsistent picture of very low to very high rejection rates with regard to the recognition or rejection of converts by the Federal Office for Migration and Refugees (BAMF) and the administrative courts, which suggests subjective examination procedures.

"There appears to be a tragic disregard for the application of a uniform and objective standard of examination for these kinds of dire asylum cases, in violation of international law. When decision-makers and judges decide on asylum applications according to their own criteria and without regard for the on-the-ground situation in the countries of origin, it results in severe personal suffering. H.H.'s case is a very worrying example of this," said Lidia Rieder.

### ***Situation of Christians in Iran worsens***

Iran is ranked 9th on the World Watch List, a ranking of countries with the worst persecution of Christians worldwide. The extent of persecution is "extreme".

In 2021, Iran passed amendments providing for prison sentences for “insulting Islam” and “deviant activities”. Last year, several Christians were arrested on this basis, charged and sentenced to five years in prison each. According to a report by the US Commission on International Religious Freedom, the persecution of converts to Christianity is particularly bad.

“Every person must be able to freely choose their faith. Iran systematically fails to protect its citizens’ right to religious freedom. Iranian law must be amended to be brought into accordance with international human rights law, which protects the right of every individual to choose and freely practice their faith. Until this happens, countries like Germany have a responsibility to help to protect vulnerable religious minorities when they have an opportunity to do so. Ignoring that responsibility can have fatal consequences.” said Kelsey Zorzi, Director of Global Religious Freedom at ADF International.

## Iranian Christian converts struggle to get asylum in Germany

***Human rights activists and pastors denounce that “the recognition rate of asylum applications has dropped from close to 100% to close to single digits”.***

Evangelical Focus (05.08.2022) - <https://bit.ly/3dvMhk7> - According to human rights activists, asylum applications by **Iranians** who have converted to Christianity have less and less chance of success in **Germany**.

“**Human rights violations on religious grounds are an everyday reality in the country**”, said Martin Lessenthin, board spokesman of the International Society for Human Rights (**IGFM**), in a press conference about the situation of Christian converts from Iran in Germany.

At the IGFM's press conference, pastor Gottfried Martens called the **Federal Office for Migration and Refugees (BAMF)** “a political authority that **is not concerned with the individual case of an asylum application**”.

According to Martens, “the **recognition rate of asylum applications** from Christian converts **has dropped from close to 100%** a few years ago **to now a figure close to single digits**”.

He pointed out that **politicians show a “certain indifference” and “shrug their shoulders”** when Christians from Iran are deported because of their faith.

### ***Administrative courts***

Martens stressed that the **asylum seekers “have no choice but to go to the administrative courts”**. The trials he has experienced with converts from Iran and

Afghanistan of his church, “are often a pure game of chance. I wonder how that could be reconciled with the rule of law”.

“In many cases these **administrative judges presume to be experts in matters of faith** in such a way that one is simply stunned. They would sometimes openly say that they knew better about the seriousness of a conversion than a pastor”, he added.

For the pastor, “the hearings are less about the seriousness of the conversion and much more about the personal attitude of the judge”.

### **Churches support**

Lessenthin also **called on “to the churches, especially the big churches in Germany, to [stand up](#) for the interests of their brothers and sisters in faith”**.

“This is where the church leadership would have to position itself more clearly” , concluded the IGFM spokesman.

### **Afif Na'imi and Saamaan Ostavaar arrested in Karaj**

Hrana / Sens Daily (31.07.22) - Following on today's previous report from Karaj, that the homes of **Kaamyaaar Habibi, Saamaan Ostavaar and Mozaffar Nabili** were raided, HRANA now reports that **`Afif Na'imi** and Saamaan Ostavaar were arrested, and that the homes of **Nasir Heravi and Saara Sha'baan** were raided and some of their personal effects, including mobile phones, electronic devices, and printed material relating to the Baha'i Faith were seized. Correcting the earlier report, it appears that only one workplace was searched and sealed: that of Kaamyaaar Habibi. The home of `Afif Na'imi was raided in November 2020. In December 2018 he was released at the end of a ten-year prison sentence for his Baha'i beliefs. He was the last of the seven Yaran (national facilitators for the Baha'i community in Iran) to be released, although they all had 10-year sentences, because during his sentence he was granted two medical furloughs of several months, and had several periods of hospitalisation. He suffers serious heart problems, blood clots, lymph node problems and acute swelling of the throat.

### **Three Baha'is detained in Yazd: Community "suffering worst coordinated attack in years"**

Iran Press Watch (25.07.22) - IranWire understands that three Bahá'í citizens near the city of Yazd, - **Nematollah Shadpour** and his son **Nima Shadpour**, and another individual, **Shafiq Eslami** - were arrested after being summoned to appear before judiciary officials. The Shadpour family are farmers and cattle breeders outside Yazd. A source told IranWire that security agents then searched the homes and places of business of these citizens and confiscated several of their belongings.

### **Baha'i citizen Haleh Gholami imprisoned**

Freedom of religion is a breach of Article 18 of the Universal Declaration of Human Rights and Article 18 of the International Covenant on Civil and Political Rights. The United Nations Covenant holds that every person has the right to practice religion freely, freedom of converting to a religion, as well as freedom of expression, individually or collectively, openly or secretly.

#### **Fardin Qamsari begins a 1-year sentence in Tehran**

His arrest, in October 2019, and sentencing were not previously reported on Sen's Daily. ## **A Tehran court sentences seven Christians, including a clergyman, to a total of 32 years in prison**

***Rev Joseph Shahbazian gets 10 years in prison, plus other penalties, including a ban on travelling abroad. Two converts get six years, while four other Christians can pay a fine to avoid jailtime. During the trial, the presiding judge, Iman Afshari, subjected the defendants to pressures, threats and humiliation.***

**AsiaNews (08.06.2022) - <https://bit.ly/3xiMCMZ>** - An Iranian court has sentenced an Iranian-Armenian Christian clergyman to 10 years in prison. Along with him, two women converts from Islam were also given a six-year sentence for their role in house churches.

The court decision against **Joseph Shahbazian** and the two converts (*pictured*) came yesterday, this according to *Article18*, an advocacy group that documents religious oppression in Iran.

Four other Christians – **Salar Eshraghi Moghadam, Farhad Khazae, Somayeh (Sonya) Sadegh and her mother Masoumeh Ghasemi** – were also given sentences ranging from one to four years but were also offered the option of paying fines ranging from US\$ 800 to US\$ 1,250 each in order to stay out of prison.

In total, the seven Christians were sentenced to 32 years in prison. However, the fate of **Rev Joseph Shahbazian, 58**, and the two converts – **Mina Khajavi, 59 and Malihe Nazari, 48**, is different. **All three will have to go to prison following the sentence imposed on 29 May** by Judge Iman Afshari, head of the 26th Branch of the Tehran Revolutionary Court.

The harshest sentence was imposed on **Rev Shahbazian**. In addition to his **10-year prison sentence, the Iranian-Armenian clergyman will serve two years of internal exile** in a remote province in south-eastern Iran.

After his release, he faces **a two-year ban on travelling abroad or membership in any political or social organisation, and must report to Iran's intelligence service for two years on an unspecified "seasonal basis"**.

In reading the verdict, Judge Afshari, who is building a reputation for convicting Christians, stressed that **the clergyman "established a group to attract Muslims" and "under the cover of religious programmes for prayer has propagated Evangelical Christianity"**.

The judge accused the Christian pastor of engaging in "illegal activities and unfounded claims" and so "abused people's inner weaknesses and attracted some of them" to "his group".

Local sources report that, during a trial that lasted no more than four hours, Judge Afshari tried to put pressure on the two women defendants with the promise of a lighter sentence if they blamed Rev Joseph of cajoling them into converting.

Faced with their refusal, he threatened to increase their sentences. Using "harsh and sarcastic language", he tried to "humiliate them and denigrate their beliefs". When the defendants' lawyer objected, he replied that he was "only joking."

The crackdown against this group of Christians is but the latest in a long series. Last month, another court imposed a 10-year sentence on another Iranian-Armenian, **Anooshavan Avedian**, for "propaganda contrary to and offensive to the holy religion of Islam".

Experts and activists are increasingly worried about the escalating **violations of religious freedom**, which are also affecting Baha'is, Sufis, Sunnis and atheists.

Local sources report blatant violations of the right to defence, with insults against people and their religion during trials, as well as "confessions" extorted by force or deception during imprisonment.

In recent years, Iranian authorities have arrested thousands of Christians who worship in house churches with hundreds convicted on charges of "action against national security".

All this refutes claims by the Iranian government and its diplomats that Christians enjoy religious freedom and the right to worship in their churches and dedicate themselves to their own activities.

### Baha'is

#### Sa`ideh Khasousi free on bail in Tehran

Hrana / Sens Daily (25.05.22) - **Mrs. Sa`ideh Khasousi** was released from Evin Prison on bail of 2 billion tumans (44,000 euros ; \$US 47,000) on May 24. She was arrested on April 11.

#### Amin Dhulfaqaari begins 8-month sentence in Yazd

Hrana / Sens Daily (25.05.22) - **Amin Dhulfaqaaribegan** his prison sentence in Yazd on May 24. Amin Dhulfaqaari was arrested by agents from the Ministry of Intelligence on May 21, 2021 [but the HRANA report says 2020], and released on bail on June 23. He was accused of teaching the Baha'i Faith. In July 2021 the Revolutionary Court in Yazd, presided by Judge Reza Javad Musavi sentenced him, and three other Baha'is, to two

years and eight months in prison for membership of anti-regime groups, and to eight months in prison for propaganda against the regime. The Review Court rejected the charge of membership of anti-regime groups and reduced these sentences to eight months.

### **Sa`ideh Khasousi's interrogation ends after 40 days**

Hrana / Sens Daily (24.05.2022) - After over 40 days' detention by Iran's Revolutionary Guards, **Mrs. Sa`ideh Khasousi** has been transferred to Tehran's Evin Prison. Her son Arsalaan Yazdaani reports that she will be released on bail. She was arrested on April 11 after responding to a summons to the court at Evin Prison in Tehran. On May 19 she was allowed a telephone call and told her family she was being (or had been?) transferred to the Revolutionary Guards' interrogation centre "A1". Her son **Arsalaan** was arrested on September 1, in a raid on the family home, and taken to Evin Prison. The agents also seized some personal effects. In another raid on September 30, agents seized more personal belongings, including Mrs. Khasousi's new mobile phone. Arsalaan was released on bail on October 16 after 45 days in detention, however Mrs. Khasousi was summoned to Evin prison in late March, only to be told she should return on April 11, which she did.

### **Group of 26 Baha'is to stand trial six years after arrests**

Iran Press Watch (24.05.2022) - A group of 26 Iranian Baha'is who were arrested almost six years ago in September 2016 were due to appear in court on Wednesday even though a judge has repeatedly called the case against them "incomplete". Prosecutors recently issued a fresh indictment against the 26 and sent the case to Branch 1 of Shiraz Revolutionary Court. The group are variously charged with "propaganda against the regime", "membership in groups opposed to the Islamic Republic", "organizing an anti-regime group" and "connections to hostile governments".

### **Sahba Farnoush begins 2-year sentence (reduced from 6 years)**

Hrana / Sens Daily (13.05.2022) - **Sahba Farnoush** began serving his two-year sentence in Tehran's Evin Prison on May 11. He was initially sentenced to 16 years, which was reduced to six years by the Review court for Tehran Province. This was appealed to the Supreme Court, which reduced the sentence to two years. His crime was celebrating the birthday of Baha'u'llah. Mr. Farnoush was arrested by agents from the Ministry of Intelligence on November 15, 2015. He was one of 20 Bahai's arrested in Tehran, Isfahan and Mashhad on that day. Agents from the Ministry of Intelligence also closed down Baha'i-run businesses in the Province of Mazandaran. It appears that the Ministry of Intelligence actions all related to Bahai's commemorating the birth of Baha'u'llah.

### **RWCHR Statement concerning the confiscation of Bahá'í property in Iran**

Iran Press Watch (10.05.2022) - The Raoul Wallenberg Centre for Human Rights (RWCHR) strongly condemns the continued confiscation of Bahá'í-owned property by Iranian authorities. Recent reports from the Bahá'í International Community found that groups connected to Iranian leadership are "orchestrating a rising trend of confiscations of properties belonging to Iranian Bahá'ís," including in Ivel, Semnan and Kata, among other localities. The UN Special Rapporteur on Freedom of Religion or Belief recently

cited property confiscation as a dimension of “state-driven and systematic” persecution of Bahá’ís in Iran.

## **Second Iranian Christian woman began prison sentence on Easter Saturday**

Article 18 (28.04.2022) - <https://bit.ly/381Da8p> - A second Iranian woman convert to Christianity began a two-year prison sentence on Easter Saturday on charges related to the practice of her faith.

**Sakine (Mehri) Behjati** handed herself in to the authorities at Evin Prison in Tehran on the same day as [Fariba Dalir](#), and both are now serving two-year sentences on similar charges.

Mehri was later permitted a transfer to Lakan Prison in her home city of Rasht, so she could be closer to her young child.

### **Who is Mehri Behjati?**

Mehri was one of four Christian converts first arrested in February 2020 for their membership of a house-church in Rasht.

The four Christians – also Mehri's nephew [Hadi \(Moslem\) Rahimi](#) and married couple Ramin Hassanpour and Kathrin (Saeede) Sajadpour – were officially charged in May 2020 and [taken to Lakan Prison](#) after being unable to afford the bail set for them – of 500 million tomans (around \$30,000).

They were eventually [released](#) a week later on reduced bail of 200 million tomans (\$11,500).

The Christians were sentenced in August 2020 to between two and five years in prison for "acting against national security" by belonging to a house-church and "spreading Zionist Christianity". Ramin was given a five-year sentence, Moslem four years, and Mehri and Saeede two years.

Their appeals were rejected in September 2020.

On 9 January 2022, Moslem left behind his nine-month-old daughter to [begin serving his four-year sentence](#) at Evin Prison so that the property deed submitted by a friend to secure his bail may be released.

A month later, the other three Christians were [told](#) they must hand themselves in to the authorities in Tehran by the end of February. However, Mehri was later permitted an

additional six weeks at home, in order to be able to spend the Iranian New Year, Nowruz, with her family.

Mehri and her nephew, Moslem, applied to the Supreme Court for a retrial, but their applications were rejected by Branch 9 of Iran's highest court in February.

## Christian woman convert begins two-year prison sentence

Article 18 (16.04.2022) - <https://bit.ly/3KKmfUZ> - A 51-year-old woman Christian convert today began serving a two-year prison sentence in Tehran's Evin prison for "acting against national security by establishing and leading an Evangelical Christian church".

**Fariba Dalir**, whose case has not been reported until now, was one of six converts arrested in Tehran in July last year, including her fiancé at the time and now husband, Soroush.

Five of the Christians were sentenced in December – Fariba to two years, and the other four, including Soroush, to 10 months for membership of the church.

However, due to time already spent in detention, these four were told they could instead choose to pay fines of 5 million tomans each (around \$250) to escape further imprisonment.

The sixth Christian, a 17-year-old girl, was released without charge, but only after spending 10 days in solitary confinement, and being subjected to intense interrogations in a detention centre of the Revolutionary Guard Corps.

Fariba and Soroush themselves each spent over a month in solitary confinement at the detention centre following their arrests on 19 July 2021 – Fariba at a hair salon, and Soroush while driving his car.

Three of the other Christians, including the 17-year-old and another woman and her daughter, had been arrested at their homes the previous day.

The sixth Christian, a man, was arrested on the same day as Fariba and Soroush, but the names of these other Christians have not been divulged.

After spending around 50 days each in solitary confinement, Fariba was transferred to Qarchak women's prison and Soroush to the Greater Tehran Penitentiary, where they were detained for two months longer, before being released on bail – of 600 million tomans (\$25,000) for Fariba, and 300 million tomans (\$12,500) for Soroush.

The couple married in the months between their release and sentencing, which took place on 4 December 2021 at Branch 26 of Tehran's Revolutionary Court, but now they are apart again.

Fariba was in fact initially sentenced to five years in prison after the court wrongly stated that she had a previous criminal record. Her sentence was later revised once the court was informed of the error.

#### **Iranian Baha'is sentenced to 170 years in prison in 1400**

Iran Press Watch (31.03.22) - The Iranian calendar year 1400, which ended on March 20, appears to have been one of the hardest in recent years for the country's dwindling Baha'i population. Mrs. Saabet was arrested in her home in Shiraz on September 1, 2019. She was initially sentenced to six years in prison, by Judge Sayyid Mahmud Saadaati, on charges of "propaganda against the regime and membership in anti-regime group." This was reduced to two years by the Review Court.

#### **Baha'i citizen Shahram Najaf-Tomaraei jailed in Evin prison**

Iran Press Watch (15.03.22) - Last Sunday, March 13, 2022, Baha'i citizen Shahram Najaf-Tomaraei was sent to Evin Prison to serve his two-year sentence. Earlier, the Revolutionary Court of Tehran sentenced him to two years imprisonment. According to HRANA, the news agency of Human Rights Activists, Baha'i citizen Shahram Najaf-Tomaraei was jailed in Evin prison for sentencing.

#### One year imprisonment against Baha'i citizen Shiva Khalili upheld on appeal

Iran Press Watch (24.02.2022) - Recently, the Court of Appeal of Mazandaran Province upheld the initial verdict of one year in prison against Baha'i citizen Shiva Khalili. Moreover, in this verdict, her cell phone, which they ruled has been used as a "crime tool", will be confiscated.

#### Saba Sefidi free on bail

Since then, she has had only brief contact with her family. There is no indication of the reason for her arrest and detention.

#### Naatoli Derakhshaan free on bail

Hrana / Sens Daily (09.02.2022) - <https://cutt.ly/nAw7bNR> - **Naatoli Derakhshaan**, a Baha'i poet, has been released on bail pending his trial. The Public Prosecutor has claimed that he was arrested in relation to membership of a pyramid selling scheme. He

was previously arrested by agents of the Ministry of Intelligence on February 21, 2012, and released on bail of 200 million rials (13,000 euros, \$US18,000) on March 27 that year. The charge against him was said to be "propaganda against the regime." He had published an open letter to Ayatollah Khamenei, drawing attention to human rights violations against the Baha'is and others in Iran, the exclusion of Baha'i youth from tertiary education, and the false denials of these facts by Iran's representatives at the United Nations. Mr. Derakshaan himself is excluded from tertiary education because he is a Baha'i.

### **Four Baha'i citizens still in detention and awaiting legal process**

Iran Press Watch (8.02.2022) Four Baha'i citizens, **Natoli Derakhshan**, **Saba Sefidi**, **Pari Kargarian Marvasti** and **Daniel Bani-Nejad**, are still in detention and awaiting further legal proceedings. On January 11, Derakhshan and Sefidi were arrested in Sari and Tehran cities, respectively. Marvasti and Bani-Nejad were also arrested last week in Marlik District, located in Tehran Province.

### **Case closed: Christians' house-church worship was not 'action against national security'**

Article 18 (28.02.2022) - Nine Christian converts who spent a combined nearly 20 years in prison for "acting against national security" and "promoting Zionist Christianity" have been acquitted by a Tehran appeal court.

The ruling by Branch 34 of the Tehran Court of Appeal, issued and communicated to the nine Christians today, comes after a Supreme Court judge ordered a review of their convictions in November.

### **Iran's Vatican embassy angry at claim Catholic archbishop and nun denied visas**

In the article, published by AsiaNews on 16 February, Chaldean bishop Thomas Meram of Urmia explained the "many difficulties" faced by the Catholic community in Iran, while it was also noted how the new Catholic archbishop, Fr Dominique Mathieu, had not been able to enter Iran despite his appointment by the Pope early last year, and how a long-serving Italian nun, 75-year-old Sister Giuseppina Berti, was also denied a renewal of her visa.

### **'We are just Christians worshipping according to the Bible,' say converts in last defence**

Article 18 (16.02.2022) - Three Christian converts facing up to 10 years in prison for alleged "deviant propaganda" and ties with foreign organisations have denied all the charges against them and said they are "just Christians worshipping according to the Bible".

**Ahmad Sarparast, Morteza Mashoodkari, and Ayoob Poor-Rezazadeh**, who were giving their last defence this morning at Branch 2 of the Revolutionary Court of Rasht, in northern Iran, added that they "have not engaged in any propaganda against the regime or any action against national security".

### **Christian converts absolved by Supreme Court now face 'propaganda' charges**

Two of the nine Christian converts cleared by a Supreme Court judge of "acting against national security" have now been charged with "propaganda against the state".

Just six weeks after they were released from prison pending a review of their five-year sentences, **Behnam Akhlaghi** and **Babak Hosseinzadeh** were summoned last week to see a Tehran prosecutor, who on Saturday told them to return today with pay slips so they could be officially charged and released on bail.

### **Baha'is**

#### **Farhaam Saabet and Farzaan Ma`sumi begin 2-year prison terms**

Hrana / Sens Daily (26.01.2022) - <https://cutt.ly/mOYKHRJ> - On January 23, **Farhaam Saabet** and **Farzaan Ma`sumi** reported to Adelabad Prison in Shiraz to begin serving their 2-year sentences. Mr Saabet and Ma`sumi were initially sentenced to five years in prison (with an additional one-year concurrent sentence) by Judge Sayyid Mahmud Saadaati, sitting in the Revolutionary Court in Shiraz. The Provincial Review Court reduced this to two years in prison.

#### **Jamaal Afshaar bailed in Ahvaz**

Hrana / Sens Daily (22.01.2022) - <https://bit.ly/3AYVkkV> - **Jamaal Afshaar** was freed on bail from the Central Prison in Ahvaz on January 22. He is the last of seven Baha'is arrested in home raids in Mahshahr on December 27 to be freed. Five of these were questioned and released after a few hours, while Behzaad Afshaar was bailed on January 14.

#### **Negaar Nasiri summoned in Tabriz**

37." Her husband **Sina Shahri** was arrested during a raid on their home in Tabriz last week (the precise day is not specified).

### **Property of Shayda Taa'id confiscated by Article 49 court**

Hrana / Sens Daily (20.01.2022) - <https://cutt.ly/OOYXrJi> - A special court for Mazandaran Province has ruled that the property of **Shayda Taa'id**, a Baha'i living in Nur County, Mazandaran, should be seized and handed to "The Executive Headquarters of the Imam." This organisation, known as **Setad**, is a parastate organization controlled by the Supreme Leader of Iran. It was created from thousands of properties confiscated in the aftermath of the 1979 Islamic Revolution, and serves as a front company for the dubious assets of the ruling elite.

### **Samira Ebraahimi arrested, released on bail**

Hrana / Sens Daily (16.01.2022) - <https://bit.ly/3Lc4eQP> - **Samira Ebraahimi** was arrested in Tehran on January 10, after answering a summons, and freed from Evin Prison on bail on January 11. Bail was unusually high, at 800 million tumans (165,000 euros ; \$US 189,000). Mrs. Ebrahimi is the wife of **Arsalan Yazdani**, who was arrested on September 1, 2021, in a raid on the family home. He was detained for 45 days, and then released on bail of one million tumans (200 euros ; \$US 240).

### **Behzaad Afshaar released, Jamaal Afshaar still held in Ahvaz**

Hrana / Sens Daily (15.01.2022) - <https://bit.ly/3LjnvjA> - **Behzaad Afshaar**, A Baha'i from Mahshahr, in Southwest Iran, was released from Ahvaz prison on bail on January 14, while **Jamaal Afshaar** is still detained in Ahvaz. They were among seven Baha'is arrested in home raids in Mahshahr on December 27. The other five were questioned and released after a few hours.

### **Baha'i poet Naatoli Derakhshaan arrested in Sari City**

### **Samira Ebraahimi summoned for questioning again**

She is due to report to the court on January 8. Her previous questioning was about December 21. Arsalan Yazdani was arrested on September 1, 2021, in a raid on the family home. He was detained for 45 days, and then released on bail of one million tumans (200 euros ; \$US 240).

### **Seven arrested in home raids in Mahshahr: two still held**

were questioned and released, and two have been taken to the city of Ahvaz, capital of Khuzestan Province. They are **Jamaal Afshaar** and **Behzaad Afshaar**. The five who questioned and released a few hours later are **Farideh Farzaaneh, Mehraan Afshaar, A`zam Afshaar, Kiomaarth Afshaar** and **Golnoush Afshaar**. During the raid, some personal effects were seized. Mehraan, A`zam and Golnoush Afshaar were also summoned to return to the Security Agency next day, when they were again questioned and released after a few hours.

### Date set for historic appeal hearing

The eight men – **Shahrooz Eslamdoust, Behnam Akhlaghi, Babak Hosseinzadeh, Mehdi Khatibi, Khalil Dehghanpour, Hossein Kadivar, Kamal Naamanian and Mohammad Vafadar** – were informed yesterday by SMS that their appeal will be heard on 22 February at Branch 34 of Tehran’s appeal court.

## Convert begins four-year prison sentence for ‘spreading Christianity’

Article 18 (11.01.2022) - <https://bit.ly/32fNEy0> - Christian convert Hadi (Moslem) Rahimi has begun serving his [four-year prison sentence](#) for “acting against national security” by attending a house-church and “spreading ‘Zionist’ Christianity”.

The 32-year-old delivery driver, who has a nine-month-old daughter, handed himself in to Tehran’s Evin Prison on Sunday morning (9 January) so that the property deed submitted by a friend to secure his bail may be released.

Moslem was one of four Christian converts to [receive sentences](#) in August 2020 of between two and five years in prison.

Moslem was given a four-year sentence, while Ramin Hassanpour was given five years and there were two-year sentences for Ramin’s wife Saeede, and another woman, Sakine (Mehri) Behjati.

Their appeals were rejected in September 2020.

The other Christians remain free on bail, for now.

### Background

The four Christians, all members of the non-Trinitarian “Church of Iran”, were first arrested in February 2020.

In May 2020, they spent a week in Lakan Prison in Rasht, having been [unable to afford](#) the 500 million toman bail (\$30,000) set for them after the charges against them were read out at Branch 10 of the Revolutionary Court in Rasht.

They were eventually [released](#) on reduced bail of 200 million tomans (\$11,500).

Ramin and Kathrin have two sons – one of whom was 16 when they were taken to prison and forced to look after himself for the week – and the other was just seven and therefore went to stay with his grandfather.

## Iranian churches get behind #Place2Worship campaign

Article 18 (14.01.2022) - <https://bit.ly/3qFaloA> - Iranian-speaking churches in the diaspora have added their voice to the call for Persian-speaking Christians to be given a place to worship.

The [#Place2Worship](#) campaign was launched late last year in response to a question from three Christian prisoners of conscience, who [asked](#) where they might worship once they were released, having been imprisoned for gathering together in house-churches because converts to Christianity are not permitted to attend the churches of Iran's recognised Christian minority of ethnic Armenians and Assyrians.

This campaign has been supported by numerous former prisoners of conscience, and now has the support of 33 churches from 10 different countries – the UK, USA, Canada, Turkey, Netherlands, Germany, Sweden, Austria, Norway, and Georgia.

Their joint statement, and the list of signatories, can be read below:

### **Statement by Iranian churches in support of the #Place2Worship campaign**

We, the leaders of Persian-speaking churches outside Iran, in unison with imprisoned Christians, have a simple question for the authorities of the Islamic Republic: "Where can a Persian-speaking Christian worship?" and not risk imprisonment.

We also join Article18 in noting that Persian-speaking Christians are not only deprived of a church but are also arrested by security agents when they gather in their homes to pray and read the Bible. So not only have these citizens been deprived of their freedom of thought, religion and community, but they and their families are not even safe at home.

The Iranian government has not stopped at closing churches; it has even turned the worship of Christian converts into a security issue, by confiscating their Bibles and sentences these citizens to long prison terms.

In the last four decades, Persian-speaking churches have been closed and many imprisoned Christian leaders have been forced to flee, and some have even been killed.

Deprivation of a church is the tip of the iceberg of structural discrimination and systematic repression against Persian-speaking Christians.

The government does not recognise the Persian-speaking Christian minority, depriving them of their basic human rights and rights as citizens. In the view of the Islamic Republic, the hundreds of thousands of Christian converts have no formal existence and are nothing more than ghosts.

So standing together with the [#Place2Worship](#) campaign, we call on the Iranian government to stop persecuting Persian-speaking Christians, to recognise the human rights and citizenship rights of this minority, and to allow them to have a church.

We note that according to the International Covenant on Civil and Political Rights, to which Iran is a signatory, "Everyone shall have the right to freedom of thought, conscience and religion. This right shall include freedom to have or to adopt a religion or belief of his choice, and freedom, either individually or in community with others and in public or private, to manifest his religion or belief in worship, observance, practice and teaching."

We also call on all Iranians to stand by Christian citizens in this campaign and not to leave them alone in their campaign for freedom of belief.

## Nine Christian converts conditionally released following Supreme Court ruling

Article 18 (01.01.2022) - <https://bit.ly/3HYUvLz> - Nine Christian converts serving five-year prison sentences for their involvement in house-churches have been conditionally released from prison, pending a review of their case.

The nine men were informed on Wednesday 29 December that they would be released on or before the New Year.

The first of the men, Abdolreza Ali Haghnejad, was released from Anzali Prison the following day, 30 December, and the remaining eight were released from Tehran's Evin Prison earlier today.

Their conditional release follows a [Supreme Court ruling](#) in November, in which the judges questioned the legality of their conviction and affirmed that "merely preaching Christianity, and promoting the 'Evangelical Zionist sect', both of which apparently means propagating Christianity through family gatherings [house-churches], is not a manifestation of gathering and collusion to disrupt the security of the country, whether internally or externally".

This decision followed the launch of a campaign, [#Place2Worship](#), which was inspired by two of the nine men, Behnam Akhlaghi and Babak Hossainzadeh, who during a short furlough in October had recorded videos and wrote an open letter to the Iranian authorities asking, "Where can we, as Persian-speaking Christians, worship once we have finished serving our prison sentences?"

All nine men – [Abdolreza Ali Haghnejad](#), [Shahrooz Eslamdoust](#), [Behnam Akhlaghi](#), [Babak Hosseinzadeh](#), [Mehdi Khatibi](#), [Khalil Dehghanpour](#), [Hossein Kadivar](#), [Kamal Naamanian](#) and [Mohammad Vafadar](#) – are members of the non-Trinitarian "Church of Iran" from the northern city of Rasht.

They were arrested during raids on their homes and house-churches in January and February 2019, and each [sentenced](#) to five years in prison in October 2019 by Judge Mohammad Moghiseh, who has earned the nickname the "Judge of Death" for his harsh treatment of prisoners of conscience.

The Supreme Court verdict issued on 3 November had paved the way for their immediate release – until a Revolutionary Court had time to reconsider their case and issue a fresh judgment – however for unknown reasons their release was delayed until now.

Their temporary release is not related to a recent directive of the judiciary to give a 10-day furlough to Christian prisoners over the Christmas period, as prisoners convicted of "acting against national security", or sentenced to more than five years, were not included in the directive.
