China forcibly repatriates North Korean refugees—especially Christians

Those who had any contact with religion in China may be jailed for life when they return to North Korea.

[Bitter Winter](#) (14.11.2023) - We are all accustomed to deal with refugees “from” China. Yet, as strange as it may seem, there are also refugees who go “to” China. What kind of refugees would escape to China believing [Xi Jinping](#)’s country is freer than their own? The answer is—North Koreans.

China is one of the worst countries in the world for [human rights](#). North Korea is “the” worst. You have better chances to be arrested, tortured, and executed in North Korea than in any other country of the world [for a variety of reasons](#), and even for no reason whatsoever. If they could, North Koreans would escape elsewhere, but geography is such that from some parts of their unfortunate country the only place they can go with some chances of success in crossing the border is China, although some die while trying.

However, North Korean refugees are not safe in China. Young women may profit of the shortage of brides in China, a relic of the one-child policy when families aborted the girls and kept the boys, and marry a Chinese. However, there are many horrific tales of North Korean “slave brides” who never learn to speak Chinese and are abused and terrorized by their husbands. Other North Korean girls end up in the hands of Chinese organized crime and are trafficked as prostitutes.

Yet, this is not the worst possibility for North Korean refugees. The worst fate awaits those China decides to deport back to North Korea, something [Xi Jinping](#)’s regime does regularly, although somewhat capriciously. On October 25, 2023, a brave North Korean woman who was once repatriated from China and finally succeeded in escaping, [gave a lecture in London](#). Her name is Kim Eunsun, and she published in 2012 her memoir “A Thousand Miles to Freedom,” translated into several languages.

Kim reported that China just deported back to North Korea 600 refugees, and may deport another 1,000 soon. Kim said life for refugees in China is precarious. They are expected not to “make trouble” or they are deported immediately. She offered the example of young girls who are raped. If they go to the Chinese police, rather than being helped they are deported. Yet, they still prefer to remain in China rather than being repatriated to North Korea. They know they will be jailed, tortured, and possibly killed there.

Since pregnancies need authorization in North Korea, if deported back to China “pregnant women are subjected to unspeakable abuse, beatings and in some cases forced abortions,” Kim added.

Chinese authorities treat those they have decided to repatriate as criminals. “Forced repatriation is also accompanied by [human rights](#) violations in China,” Kim said. “In the Chinese border security centers, [those awaiting deportations are] forced to defecate in plastic buckets in cells with surveillance cameras operating 24 hours a day and sometimes have to listen to the sounds of screams as people are beaten and shocked with electric batons. The [human rights](#) violations that occur during and after forced repatriation are ruthless and dehumanizing.”

Kim added that the North Korean regime has spies in China. The refugees who get in contact with religion there, which mostly means Christian churches, may be jailed for life if they are repatriated. It does not matter whether the church they contacted was part of the [CCP-controlled Three Self Church](#). "Those who have been involved with churches in China are subjected to harsh interrogation. I never saw anyone who faced those interrogations ever released from detention. Merely meeting a Christian in China makes one a political criminal," Kim said.

10.11.2023 - Anhui: Bringing opera to villages—and anti-religious propaganda

13.11.2023 - China's new law on religion: A great leap backward

His movement was successful in Australia and became a global phenomenon, with hundreds of thousands of followers (the movement claims they are ten million, but the figure is disputed).

04.11.2023 - Spain, Church of Almighty God performer tries to commit suicide rather than being deported to China

Bitter Winter - She starred in "Xiaozhen's Story," now her life is at risk. Others are in a similar situation in Madrid. They need immediate help.

A well-known performer tried to commit suicide at Madrid Barajas Airport on November 3 by cutting her wrists rather than being deported back to China, where she would face imprisonment, rape, torture, and possibly death. She is Li Yanli, a member of The Church of Almighty God (CAG), a Christian new religious movement that is both heavily persecuted in China and well-known for its artistic productions. CAG movies have won awards from Christian film festivals' juries that did not agree with the movement's theology but were won by the quality of the films.

12.11.2023 - 55-year-old Jiangxi woman sentenced to 3.5 years for her faith still held in a Police Hospital

ChinaAid - It was recently learned that a 55-year-old woman in Nanchang City, Jiangxi Province was sentenced to three and a half years in prison, with a 10,000-yuan fine, for her faith in Falun Gong.

Ms. Xu Zhen was arrested on March 12, 2023 and stood trial at the Xihu District Court on September 28. It is unclear when exactly she was sentenced. She has filed an appeal with the Nanchang City Intermediate Court.

Ms. Xu developed severe health symptoms not long after her arrest and was hospitalized multiple times in the following few months. She remains at a police hospital at the time of this writing.

29.10.2023 - After nearly 11 years of incarceration, 70-year-old man gets another 4 years for practicing Falun Gong

Minghui - A 70-year-old man in Mishan City, Heilongjiang Province was sentenced to four years with a 10,000-yuan fine on October 18, 2023, for his faith in Falun Gong, a mind-body.

This is not the first time that **Mr. Zhang Yutang** has been targeted for his faith. He was previously given two years of forced labor in 1999 and thrice sentenced (receiving three years in 2003, five months in 2012, and 5.5 years in 2014). He was brutally tortured each time. His local government stopped his pension (a bit over 100 yuan each month) in early 2022, and he struggled to make ends meet.

14.11.2023 - Activist Zhu Yufu arrested for trying to leave China

ChinaAid- Prominent pro-democracy activist **Zhu Yufu** from Zhejiang was arrested by Chinese border guards at the China-Vietnam border. He suffered sudden illnesses while in custody, but the police deliberately neglected his conditions. His relatives abroad have publicly called on the Zhejiang authorities to allow him to leave the country on humanitarian grounds and visit his terminally ill sister in Japan.

In the five years since his release, pro-democracy activist Zhu Yufu from Zhejiang has remained a low profile, declining media interviews and refraining from writing articles advocating for democracy. He hoped to avoid further confrontation with the Communist Party of China's taboo on discussions about democratic politics. However, Zhu has endured years of restricted freedom. He had planned to visit his terminally ill sister with late-stage lung cancer in Sasebo, Kyushu, Japan, but authorities stopped him from doing so in March of this year.

09.11.2023 – Activist Ji Xiaolong sentenced to four and a half years in prison

ChinaAid - **Ji Xiaolong** was sentenced on Friday, October 27 to four years and six months in prison by a Shanghai court for picking quarrels and provoking trouble. He disclosed the truth about Shanghai's lockdown during last year's COVID-19 pandemic. He demanded the Chinese government relax the excessive lockdown measures and for those responsible to be held accountable for their policy making.

"All the news I received today has not been good, sentenced to four and a half years, it will take more than three years to get out of prison. (They) have not given him a haircut yet, I do not know what these officials are plotting," Ji Xiaolong's sister said in response.

He kept beating Jia up until other police eventually stopped him. Preacher Ding Shuqi was dragged and beaten up when police took him away.

23.10.2023 - 10 things to know about China's policies on religion

26.10.2023 – 'Sinicization means obedience'

ChinaAid - A fierce debate continues regarding the Communist Party's policy of Sinicization of religion. During a symposium in Hong Kong, an anonymous scholar described it as "obedience."

The symposium took place at the Chinese University of Hong Kong as it celebrated the 60th anniversary of the establishment of the Divinity School of Chung Chi College.

It was titled "Spirituality, Culture, and Chinese Societies: Interdisciplinary and Interfaith Dialogues," on October 6. Scholars expressed their views on Sinicization. One scholar quoted an anonymous scholar, stating, "To put it simply, Sinicization means obedience,"

but argued that attempts at transformation would not succeed. Another scholar remarked, "Claiming one's own culture as unique alone can bring danger."

ChinaAid - Recently, Shandong province sent out a religious belief survey form to K-12 families. The form inquired about students' and family members' religious beliefs. The survey form contains questions for students, including basic information like name, class, and address. However, it also asks about their religious beliefs, when the student became a believer and their reason for becoming a believer. The questions don't end there. Questions continue, asking children where they meet for religious gatherings, the frequency of the meetings, and the student's attitude towards religious beliefs. Each question requires detailed answers. Students are not the only ones filling out the form either. Every close family member must answer similar questions, like basic information and whether they attend religious gatherings. All of these questions will be used to further persecute all religious minorities in Shandong.

30.10.2023 - Falun Gong surgeon raped in prison and forced to drink urine

Bitter Winter - Li Lizhuang was arrested and sentenced to more than ten years in jail for promoting the "Nine True Word Meditation" during the COVID pandemic.

29.10.2023 - Disabled in the persecution of Falun Gong, 65-year-old woman faces prison sentence again

Minghui - Having become disabled due to toxic injection while serving time for practicing Falun Gong, a 65-year-old woman is facing prison sentence again for her faith.

25.10.2023 - Retired worker faces second prison term for practicing Falun Gong

Minghui - Having been sentenced to three years for practicing Falun Gong, a 65-year-old retired worker is facing a prison sentence again following his latest arrest eight months ago.

Mr. Zhou Yubao, of Shifang City, Sichuan Province, was arrested on February 24, 2023, while mailing a letter. The police raided his home and put him in criminal detention at the Shifang City Detention Center.

Mr. Zhou's family hired lawyer Zhang from Beijing on March 1, 2023. The lawyer and the family soon went to the detention center to visit Mr. Zhou. He told them that the police violated the law while handling his case, including arresting and raiding his home without showing their IDs or a search warrant. Only one arresting officer was in uniform and all of the more than a dozen officers who raided his home were in plainclothes. They did not provide a list of confiscated items as required by law.

31.10.2023 - House Church graduation ceremony interrupted, Christians taken away.

ChinaAid - On the morning of October 28, 2023, police interfered in the graduation ceremony of Early Rain Covenant Church's "Workers' College". Some Christians were taken away.

At 10:00 AM, the church held a graduation ceremony for the Workers' College in a conference room of a hotel near the Jiangxin Building. Over 30 church members attended the ceremony.

In the midst of the worship service, more than officials from the Political Security Bureau (formerly known as State Security) and the Civil Religion Bureau suddenly entered the room. More than 20 individuals, including police and community officials, interrupted the ceremony and declared the gathering illegal.

24.10.2023 - The Christian exodus from China

Mercatornet - "Run" (润) has been one of the hottest words in the Chinese language since 2021. A clever wordplay on both the Chinese pronunciation and English meaning of the word, "run" refers to the recent trend of emigrating from an increasingly restrictive and authoritarian China for greener pastures overseas.

This emigration wave, which began shortly after Xi Jinping amended the Constitution in 2018 to abolish term limits, took off during Covid and has only accelerated since. This can be reflected in the surge of illegal Chinese immigrants arriving at the US-Mexican border. In the 2023 fiscal year alone, US Border Patrol has apprehended 24,000 Chinese migrants at the Southern border, up 1,115% (i.e., 11.5 times more) than the previous fiscal year. Chinese migrants crossing the Darien Gap on their way to the US has become a common sight, with both English and Chinese-language media offering extensive coverage of this new phenomenon.

17.10.2023 – Government controlled churches must establish 'surveillance' boards

ChinaAid - Government-controlled churches in China held a supervisory board conference in Shanghai on September 26. During the meeting, they discussed a set of rules for the supervisory board and another set of methods for implementing these measures. In reality, the supervisory board functions as a "surveillance" board, aiming to facilitate mutual reporting, disclosure, restraint, and supervision within the Christian community and among Christians.

On October 2nd, the official website of the China Christian Council (CCC) and National Committee of Three-Self Patriotic Movement (TSPM), reported that their supervisory board was held in Shanghai. According to their report, Pastor Gao Feng, the chairman of the supervisory board of the TSPM, reviewed the main work of the council over the past five years. This work included convening seven board meetings and formulating two sets of new measures, both of which have not yet been officially disclosed. Chairman Gao Feng mentioned that the provincial CCCs and TSPMs in eleven provinces have established supervisory. Through discussions and exchanges, these supervisory boards may better fulfill their roles in future work on religion.

13.10.2023 - Chinese human rights lawyer held in prolonged solitary confinement

ChinaAid - According to the latest reports, human rights lawyer **Qin Yongpei** is still being held in prolonged solitary confinement. He insists on his innocence and advocates for the abolition of two charges commonly used to suppress other Chinese activists.

Qin Yongpei's defense lawyer recently went to his client. During the meeting, he learned that guards continue to hold Qin in prolonged solitary confinement. The Chinese government's sentenced him to five years on charges of inciting subversion of state power adds to the Chinese Communist authorities' long history of crime. He believes that both the incitement and subversion charges should be abolished.

13.10.2023 - Reported in September 2023: 104 Falun Gong practitioners sentenced for their faith

Minghui - The month of September 2023 recorded 104 cases of Falun Gong practitioners sentenced to prison for upholding their faith.

Among the 104 cases, 8 took place between 2019 and 2022, 14 in the first half of 2023, 9 in July 2023, 15 in August 2023, 36 in September 2023, and another 11 cases with unknown months in 2023, as well as 11 cases with unknown months and years. The delay in reporting was caused by the strict information censorship under the Chinese Communist Party (CCP), which aims to keep the persecution underground to avoid international scrutiny.

The sentenced practitioners were from 18 provinces, centrally controlled municipalities, and autonomous regions in China. Jilin had the most cases, 21, followed by Liaoning (14) and Hebei (10). The remaining 15 regions had between 1 and 9 cases.

Mr. Li was finally allowed to phone his loved ones in late August 2023 but he is still denied family visits as of now.

At least ten Falun Gong practitioners and two of their family members, all from Jiamusi City, Heilongjiang Province, were arrested between the evening of September 14, 2023 and the next morning. Below are the details.

Arrested on the Evening of September 14, 2023

Zhou Wei, the chief of Songlin Police Station, and three other officers showed up at 51-year-old **Ms. Dong Min's** home on the evening of September 14, 2023. Zhou lied to Ms. Dong's family that they would take her to the police station to sign a document and then let her go home. Two other practitioners who were arrested on the evening of September 14, 2023 were **Mr. Xu Chuan** (also known as Xu Wei), in his 40s, and **Mr. Ren Changbin** in his 60s.

ChinaAid - Catholic Bishop Yang Xiaoming from the Wenzhou Diocese in Zhejiang, China, was convicted of "fraud" because he refused to join the official Chinese Catholic Patriotic Association. It is uncommon for Catholic clergy to be punished under the charge of "impersonating religious personnel."

Sources in China told AsiaNews, Fr. Yang Xiaoming (baptismal name Joseph), was brought to court, convicted, and subjected to administrative penalties because of his refusal to join the Chinese Catholic Patriotic Association.

According to AsiaNews, Fr. Joseph Yang Xiaoming was born on November 22, 1989, in Longwan District, Wenzhou City, Zhejiang Province. On December 18, 2020, Bishop Peter Shao Zhumin ordained him as a priest. Bishop Peter Shao Zhumin, who is recognized by the Vatican, was arrested multiple times and subjected to surveillance because of his refusal to join the Chinese Catholic Patriotic Association.

05.09.2023 - Shoulder disabled by torture in Labor Camp, former engineer Mr. Huang Zhufeng sentenced again for practicing Falun Gong

Both of his shoulders were dislocated and his arms were disabled. He was unable to continue working in his profession after being released and had to do odd jobs to make a living.

Eight officers from the Gaozhou City Domestic Security Office and Chengnan Police Station broke into Mr. Yu Tao’s home on the morning of August 12, 2021, (a Thursday). Mr. Yu wasn’t home, so the police forced his high-school son to call him and ask him to come home immediately to answer the police’s questions. As soon as Mr. Yu returned, the police arrested him. They also confiscated the family’s printer and the work computer belonging to his wife, who is an accountant. None of the officers showed their IDs or a search warrant. They also refused to provide a list of confiscated items.

An officer took out his gun and threatened Mr. Yang. They photographed his home and confiscated his Falun Gong books and related materials.

14.08.2023 - China represses religions, council says

Taipei Times - China continued to repress religious freedom by destroying places of worship and detaining clergy in the first six months of the year, the Mainland Affairs Council said in a report.

Chinese officials closed down the Jokhang Temple, one of the holiest sites of Tibetan Buddhism, from March 8 to March 11, a date seemingly chosen to coincide with the anniversary of the Tibetan National Uprising Day on March 10, the council said.

Beijing has been carrying out deliberate attacks on organized religion with arrests and other means, it said, adding that religious leaders and followers were detained in tens of recorded incidents.

New massive wave of persecution against the Church of Almighty God

Over 900 members were arrested in Zhejiang Province in one day. One died after three days in custody.

[Bitter Winter](#) (11.08.2023) - The Chinese Communist Party (CCP), which has never ceased its persecution and surveillance activities against [The Church of Almighty God](#) (CAG), the largest Christian [new religious movement](#) in the country, recently launched a new coordinated arrest operation against the group. As reported by CAG members to “Bitter Winter,” the persecution was most severe in the provinces of Zhejiang, Fujian, and Jiangsu. On June 15, in just a single day, at least 905 CAG members in Zhejiang [Province](#) were placed under arrest, and until this day 282 are still in custody, facing prosecution and sentencing. One died just three days after her arrest.

Insiders within the Zhejiang provincial government told “Bitter Winter” that this coordinated arrest operation was planned up to a year ago. On the evening of June 14, the provincial [Public Security Bureau](#) issued a direct order, providing a list for arrest to [Public Security Bureau](#) departments in various [municipalities](#). Public security, national security, armed police, and special forces police carried out this joint operation to arrest CAG members. In the city of Hangzhou, 189 of them were arrested in just one day. 170 were arrested in the city of Wenzhou. Over 100 people were arrested in the cities of Jinhua and Quzhou.

Police focused on arresting leaders and active workers in an effort to entirely eradicate the CAG. It was reported to “Bitter Winter” that, while interrogating a CAG member, one officer said, “This time, we’re uprooting leaders from regions down to smaller districts, and then to [local churches](#), and the intensity of the strike will continue to increase.”

One CAG devotee who has been released revealed that in the room adjacent to where he was held, a church leader was tortured and abused for five days. Later, another church leader was also confined and then subjected to torture. This witness said, “I could hear her screams.”

One CAG member over the age of 60 died suddenly after three days of confinement. The authorities claimed that she hanged herself, but after her family viewed the corpse, they reported to “Bitter Winter” that there were no marks from hanging on her neck, but there were wounds on her head and there was blood visible in her eyes. The marks of torture were apparent.

Reportedly, many of those arrested were placed under surveillance as early as one or two years before the arrest. Government insiders revealed to “Bitter Winter” that on August 31, 2022, Zhejiang and Fujian [Province](#) authorities jointly launched “Operation 831,” comprehensively following and tracking CAG members with a combination of high-tech surveillance, Skynet system inspections, and manual tracking, leaving them with nowhere to hide. The police also hired undercover agents to implant themselves in churches by pretending to be interested in the CAG teachings. They surveyed the situation in those churches and subsequently carried out arrests.

As reported to “Bitter Winter,” during an interrogation one police officer said, “Where you’ve gone, the times you enter and leave a place, all is perfectly transparent to us. You think you’re being very cautious, but we can see right through all of you.” He also said, “The government has acquired plenty of advanced surveillance equipment just to catch people like you. We can identify you even with your hats and masks on.”

Another released CAG member stated, “This time when I was arrested, I realized that the police had used drone surveillance to lock in on me, then arrested all the brothers and sisters I came into contact with.”

According to reports, the majority of CAG devotees detained in this arrest operation were forced to attend heavy indoctrination courses, which are generally held at locations such as hotels and rural resorts and kept secret from the public. The [CCP](#) invited experts in indoctrination, high-level professors in psychology, and legal consultants. Lower-level officials were also employed to act as chaperones. They forced CAG believers to watch videos extolling the Communist Party and tried to inculcate them with a wide variety of atheistic ideas. Devotees were forced to sign the “three letters” of “repentance, guarantee, and break-up” from the CAG, thus betraying their faith.

One CAG member reported, “They forced us to watch those videos every day, report on our thoughts, and curse Almighty God—every day!” According to this informant, they were forbidden to pray, were watched while eating and sleeping, and humiliated and condemned during those classes. Many were tortured because they refused to cooperate with the indoctrination. One released CAG member told “Bitter Winter,” “If we didn’t confess, the police wouldn’t allow us to sleep, in an effort to break our spirits.”

The arrest operation is still in progress, and the persecution is just as severe in other regions. It was reported to "Bitter Winter" that during the afternoon of July 13, a CAG devotee in Jiangsu [Province](#) escaped from a basement room where she was being held, and after being pursued by the police and left without any way to escape, was forced to jump to her death from the eleventh story of the building.

It was also reported to us that a public security official announced that later this year, a second and third round of arrests of members of CAG will be carried out. The CAG remains [the most persecuted religious movement in China](#).

Falun Gong

Persecution deaths of 120 Falun Gong practitioners reported in the first half of 2023

Minghui - A total of 120 cases of Falun Gong practitioners persecuted to death for upholding their faith were confirmed in the first half of 2023.

Falun Gong, also known as Falun Dafa, is a mind-body practice based on the principles of Truthfulness, Compassion, and Forbearance. Since its introduction to the public in 1992, countless people have been drawn to its profound principles and health benefits. Fearing its ever-growing popularity, the Chinese communist regime launched a nationwide campaign in July 1999, attempting to stamp out the practice.

Hundreds of thousands of practitioners have since been harassed, arrested, detained, imprisoned, and tortured. A total of 4,974 deaths have been documented by Minghui.org as of July 14, 2023. Due to the strict censorship of information in China, however, the actual number is likely much higher.

Among the 120 newly-confirmed deaths, 26 (21.7%) took place between 2003 and 2021, 37 (30.8%) died in 2022, and 54 (45%) practitioners passed away in 2023. It isn't clear in which years three practitioners died.

RFA - Tearing down tents and destroying a colorful sand mandala, Chinese authorities on Wednesday stopped a gathering where a Tibetan Buddhist lama was scheduled to preach – and tried to block online photos and descriptions of the incident, two Tibetans with knowledge of the situation said.

The actions in northwestern China's Qinghai province are the latest efforts by China to suppress Tibetan religious and cultural expressions.

31.07.2023 - Trial for Christian music school principal Xu Feng begins

ChinaAid- Chinese Communist authorities tried **Xu Feng**, a Christian music school principal, with "illegal business operations." The case began its trial on July 14th, but all information about information has been restricted.

Local authorities arrested Xu Feng, the principal of Maizi Christian Music High School, in 2021. He and his co-workers were detained for nearly two years before their trial began. July 14th was full of twists and turns. Defense lawyers summarized several features of the trial. According to the attorneys, the court violated the law before and after the trial. Meanwhile, the defense argued that the judge should not let an unjust verdict destroy the "goodness" still in society.

The description of court proceedings and the verdict in Xu Feng's case were completely censored and restricted by the Chinese government's internet censorship authorities. All information regarding the trial and its outcome was swiftly removed from the internet.

ChinaAid - Local government officials accused Linfen Covenant House Church preachers and a co-worker of "fraud." Defense attorneys Fang Xianguo and Yuan Mao informed Linfen City People's Procuratorate of the mishandling of the case by the lower district. However, the city prosecutors called the case "cult" related and refused to accept any materials.

According to Chinese law, the Yaodu District People's Procuratorate of Linfen City made an error in this case. They did not investigate police suspected of illegal collection of evidence and bending the law for personal gain.

18.07.2023 - Wife and son of Chinese human rights lawyer who died suspiciously escape to US.

ChinaAid - The wife and son of Dr. Li Baiguang, the Chinese human rights attorney who died under suspicious circumstances in 2018, have escaped to the United States, according to the Christian nonprofit groups ChinaAid and Voice of the Martyrs Korea.

Hanmei "Hannah" Xu and Qingxin "Pure Heart" Li arrived in the United States last month and are presently seeking asylum, according to representatives of the two groups.

Dr. Li Baiguang, known for his self-described "ant strategy" of traveling around China to take up hundreds of individual cases defending the religious freedom and human rights of ordinary citizens, rose to prominence internationally after receiving an award from the Washington-based National Endowment for Democracy in 2008 and being invited for three visits with then-U.S. President George W. Bush. Both Ms Hanmei Xu and Qingxin Li were summoned to the local police station nearby where they used to stay in Jiangsu province for intensive interrogation about Dr Li's human rights activities.

Sanction persecutors of Falun Gong!

[The European Times](#) (20.07.2023) - July 20 marks the anniversary of one of the bloodiest, and yet widely unacknowledged assaults on religious freedom in the contemporary world,

medieval in its violence. The terror continues and obligates national governments and civil society to defend its victims, and sanction its perpetrators.

In 1999, the Chinese Communist regime began repression and persecution of Falun Gong (also called Falun Dafa). Falun Gong is a new religious movement, established by Li Hongzhi in 1992 in China. It is nonpolitical and totally pacifist, and teaches both a variety of traditional Chinese gymnastics and a spirituality rooted in the "Three Teachings," a Chinese religion including Taoism, Confucianism, and Buddhism, with some New Age variations.

Falun Gong was originally tolerated and even praised by the Chinese Communist Party (CCP) as a healthy practice that was good for citizens, but two elements eventually aroused concern among CCP authorities. As much as the regime tried to present it as a purely secular practice, its spiritual dimension could not be denied or removed. What is more, the movement rapidly grew in size.

Considering Falun Gong a threat to its monopoly on authority, the CCP banned it in 1999, including it in the list of "xie jiao," meaning "heterodox teachings." The traditional term has been by Chinese political rulers to stigmatize groups and individuals they disliked. The CCP revived the expression, using it in the same manner term "cult" is used in some Western milieus, and started using it as a pretext to severely persecute Falun Gong practitioners and other groups.

The [Falun Dafa Infocenter reports](#) that the total number of believers documented to have died due to persecution now surpasses 5,000, with the youngest being a 17-year-old model student in Heilongjiang in August 1999, Chen Ying, and the eldest an 82-year old retired professor, An Fuzi, a Korean, who died in Jilin Province Women's Prison on May 22, 2023 after two years in detention.

The Center also documents that from January to June 2023, there were 3,133 documented cases of arrests and harassment, a 15.7 percent jump from the same period in 2022. No one should also forget that Falun Gong was for decades the preferred victim of organ harvesting, the forcible extraction of vital parts from the bodies of prisoners of conscience, some of whom are still alive, to feed the lucrative Chinese black market for transplants. Today, this practice continues and is extended also to Uyghurs and Tibetans, and possibly others; there are fears that the regime's massive DNA profiling may serve organ harvesting programs.

In 2018 and 2019, crimes perpetrated by the CCP against Falun Gong were thoroughly documented by the London-based "China Tribunal," chaired by Sir Geoffrey Nice, former lead prosecutor at the trial of Slobodan Milošević in the International Criminal Tribunal for the Former Yugoslavia.

This year, approaching the anniversary of the beginning of their persecution, Falun Gong practitioners living in 44 countries compiled a list of perpetrators and submitted it to their respective governments, urging them to hold these individuals accountable. They ask their governments [to bar these criminals and their family members from entry in those 44 countries and to freeze their overseas assets](#). Minghui.org, a volunteer organization working as central communication hub for the Falun Gong community worldwide, underlines that "[o]fficials from the U.S. State Department informed several years ago that the materials provided by Falun Gong practitioners are authentic and credible, presented in a professional manner, and can be used as a model for other groups."

Victims and survivors among the Falun Gong appealing to governments and international organizations to take action against individuals responsible for crimes against them. To hold them accountable can ease pressure against Falun Gong, and help prevent members of other religious minorities from suffering similar abuses.

Bitter Winter - "Pornography and obscenity" and "xie jiao [a term indicating 'heterodox teachings' listed as such and prohibited, sometimes less accurately translated as 'cults'], illegal religion, and superstition" are now the two main illegal contents of books the Market Supervision Bureaus are supposed to confiscate in China.

This month, Market Supervision Bureau officers and police descended on bookstores in Shangcheng County, which is under the administration of the prefecture-level city of Xinyang, in Henan Province, and started examining shelves and books, telling store owners that they were looking for both pornography and unauthorized religious or "superstitious" publications.

Bookstores near schools and colleges were particularly targeted.

Just after 10 PM, the power was cut off at the home of Pastor Huang Xiaoning of the Guangzhou Bible Reformed Church. Surveillance photos revealed that an unknown person in civilian clothes was injecting objects into the door. Pastor Huang Xiaoning reported the case to the police station that night, respectively. He received an executive police report. Reports also indicate that unknown individuals also stalked and harassed other pastoral co-workers this past week.

19.06.2023 - Chang Weiping, a Chinese human rights lawyer, sentenced

Chinaaid - Chinese human rights lawyer Chang Weiping was sentenced to three years and six months in prison for subversion of state power. He is expected to be released in July 2024.

The 39-year-old human rights lawyer Chang Weiping was involved in the "Xiamen Gathering" case in 2019. After a private dinner gathering, over 20 citizens and lawyers were forcibly disappeared, summoned, or detained. All the attendees discussed current affairs and the future of China. Two of those involved, rights activist Dr. Xu Zhiyong and lawyer Ding Jiayi, were sentenced to 14 and 12 years, respectively. Dr. Xu's girlfriend, Li Qiaochu, was also implicated and remains in custody. Other activists including Zhang Zhongshun, Dai Zhenya, and Chen Jiaping have been released on bail pending trial.

30.06.2023 - Woman previously jailed three times detained again for her faith in Falun Gong

Minghui - A 71-year-old resident of Shihe District, Xinyang City, Henan Province was arrested on May 16, 2023, while talking to people about the Chinese Communist Party's persecution of Falun Gong, a mind-body practice based on the principles of Truthfulness-Compassion-Forbearance.

Among the newly confirmed cases, 40 took place between 2016 and 2021, 8 in 2022 and 85 in 2023. The delay in reporting was caused by the strict information censorship under China's communist regime, which essentially keeps the persecution underground to avoid international scrutiny.

The sentenced practitioners are from 23 provinces, centrally controlled municipalities and autonomous regions in China. Liaoning topped the list with 19 cases, followed by Shandong (18), Heilongjiang (11) and Hebei (10). The remaining 19 regions reported sentencing cases between 1 and 9.

She urged the police not to persecute Falun Gong. She also told them how her advanced bowel cancer disappeared after taking up the practice. The police confirmed it after examining her medical records. However, they still detained her at the Zhanjiang City Detention Center and submitted her case to the Chikan District Procuratorate.

Wu Tingmin, the father of imprisoned Elder **Wu Jiannan** of Qingcaodi Church, called for his son's release.

Elders Wu Jiannan and **Hao Ming** were arrested together on November 17, 2021. Police also took many church co-workers. The next day, authorities charged Wu and Hao with "fraud" because their church accepts a tithe and offering. According to Qingcaodi Church, the alleged amount money "defrauded" from church totaled 560,000 yuan (~\$81,000).

Wu Tingmin posted an article titled "A Father's Appeal: please release my son" on the Chinese social media Weibo. "Today I want to speak up for the persecution and injustice my son Wu Jiannan underwent because of his Christian belief," he wrote.

13.05.2023 - Senior geological engineer and father of U.S. resident sentenced to eight years and fined 100K Yuan

A senior geological engineer employed by the Shengli Oilfield in Dongying City, Shandong Province, was sentenced to eight years with a 100,000-yuan fine on April 22, 2023.

Mr. Zhou Deyong was arrested on April 23, 2021, for practicing Falun Gong, a mind-body practice that has been persecuted by the Chinese Communist Party since July 1999. His arrest came six months after he returned to China from a trip to the U.S. His wife, Ms. You Ling, who traveled with him, stayed in the U.S. with their son Mr. Zhou You, who resides in Florida.

The deaths of 25 Falun Gong practitioners as a result of the persecution by the Chinese communist regime were reported in April 2023.

Six of the deaths took place between 2003 and 2020, another six in 2022, and the remaining thirteen in 2023. Due to strict information censorship in China, deaths can't always be reported in a timely manner, nor is all information readily available.

The 25 practitioners, including 16 females, hailed from 11 provinces. Hubei reported five cases, followed by four cases each in Hebei and Liaoning. Heilongjiang ranked the fourth with three cases. Hunan and Jilin each had two cases. The remaining five provinces, including Jiangsu, Jiangxi, Inner Mongolia, Shandong, and Sichuan, each had one case.

07.05.2023 - Retired preschool teacher loses pension after serving three years for her faith

Ms. Li Caixia, a retired preschool teacher from Chifeng City, Inner Mongolia, walked out of prison in July 2022 after three years of incarceration for her faith in Falun Gong, only to find that her pension had been cancelled by the Chifeng Social Security Bureau.

Meanwhile, officials from the judicial department, the police and the residential committee still constantly harass her and monitor her daily activities.

Ms. Li filed a complaint with the Songshan District Court against the suspension of her pension. It's not clear whether the court has accepted her case.

Growing up in the countryside, Ms. Li married a man in the city at the age of 23 in the hope of a better life, only to become a victim of domestic violence. Her husband treated her even worse after she gave birth to a daughter. She had to divorce him in order to survive. She and her daughter led difficult a life until she took up Falun Gong in July 1999.

28.04.2023 - Tibetan Buddhists traveling to Lhasa on pilgrimages face new hurdles

They now must file a form with a local official and have a city resident vouch for them.

Tibetans heading to the capital of Lhasa for pilgrimages or for other reasons must obtain a permission letter from a local official assuring that the traveler will not instigate or participate in any protests that would disrupt social order, Tibetans inside the region said. Many Tibetan Buddhists travel to Lhasa, which has a population of about 560,000, to visit the major religious sites such as the Potala Palace, Barkhor Street, Jokhang Temple and Norbulingka Palace.

28.04.2023 - Pastor Li Taiyun and Dr. Zhang Yi imprisoned for two years with no information on verdict.

Pastor Li Taiyuan and his wife Dr. Zhang Yi have been detained by Wuhan authorities for two years. Their case recently went to trial. The verdict is not known to the outside world because the government kept the information under tight control.

According to a church elder who knows Pastor Li Taiyuan, the case mainly involved the export of biological products, relating to their original professions. Specific details are unclear at this time. The elder who once interviewed Pastor Li said it was "too early to draw a conclusion."

Wuhan Public Security Bureau arrested Professor Li Taiyuan Dr. Zhang Yi of the College of Life Sciences of Wuhan University in May 2021. The authorities threatened them with capital punishment and heavy sentences.

According to ChinaAid sources, Li and Dr. Zhang were the project leaders of a DNA research project at the university. Authorities accused their scientific research team of traveling to Xinjiang without permission to collect Uyghur biological specimens. Police further alleged that the couple leaked research data pertaining to Uyghur fertility and genetic mapping.

On April 11, 2023, Pastor Wan Changchun of the Living Stone Reformed Church in Bengbu City, Anhui Province was arrested while serving in Lijiang, Yunnan Province. His charge was suspicion of "illegal business operations." The authorities currently hold Pastor Wan in the Bengbu City Detention Center. After Pastor Wan was arrested, police questioned his wife and the church's leadership. All the church accounts were frozen and audited. Three days after Pastor Wan's arrest, police ransacked his home.

Qin Yongpei, a Christian human rights lawyer from Guangxi, was detained by the Chinese authorities for more than three years beyond legal time limits. On March 31, Qin was convicted of "inciting subversion of state power" by the Nanning City Intermediate People's Court of Guangxi. The verdict of the first instance sentenced Qin Yongpei to five years in prison, to be followed by three years of deprived political rights. Dissatisfied with the verdict, he has appealed.

On March 31, Qin Yongpei's wife, Deng Xiaoyun, and his younger sister attended the court hearing. Two bailiffs brought him out, and he became slightly emotional. Qin Yongpei's meeting with his wife and younger sister went on for about 10 minutes, in which he signed a power of attorney entrusting his wife and daughter to be the defenders of the second instance of his appeal.

23.03.2023 - Wenzhou, parents asked to sign a "Kindergarten Family Commitment not to believe in religion"

rights lawyers as basis for his harsh sentence, saying that he had used 'illegal religious groups' to 'spread subversive thoughts and ideas'.

31.03.2023 - Targeted in a Police Sweep, Two Shandong women sentenced to prison for practicing Falun Gong

Two Dongying City, Shandong Province residents were both sentenced to 3.5 years and fined 20,000 yuan in January 2023 for their faith in Falun Gong, a spiritual discipline that has been persecuted by the Chinese communist regime since 1999.

Ms. Guo Hongyan, a 46-year-old employee of Shengli Oilfield, and Ms. Chen Xiaohong, a retired middle school Chinese teacher, were both arrested on April 23, 2021, during a police sweep. The Dongying District Court held a hearing of their case through a video call on January 14, 2023, without telling them that they had the option to request an in-person hearing.

29.03.2023 - Six Falun Gong practitioners tortured in a Shandong brainwashing Center

Six residents of Zhucheng City, Shandong Province were tortured in a brainwashing center for a month, following their arrests for practicing Falun Gong, a spiritual discipline that has been persecuted by the Chinese communist regime since 1999.

Ms. Li Yeshu, her husband Mr. Luo Wenxin, Ms. Li Mingxia, Ms. Xu Huancui, Ms. Li Hongmei, and Ms. Zheng Zhimei were arrested on March 4, 2022, and taken to the Zhucheng City Brainwashing Center, also known to the outside as the "Care Center."

Officers Song Wei, Hao Xiaojun, and Su Lei hit Ms. Li Yeshu's head, hands and body with a bamboo stick and also stomped on her. They then wrapped her hands with a wire connected to an electrical box, ordered her to sit on the ground, and turned on the switch to shock her. Her body was bounced up and down by the electric shock. Before she completely lost consciousness, she remembered someone stepping on her back against the ground.

25.03.2023 - Once incarcerated for 17 Years, Hunan Man arrested again for practicing Falun Gong

Having served one labor camp term and two prison terms totaling 17 years, a Xiangtan City, Hunan Province resident was arrested again for his faith in Falun Gong.

Falun Gong, also known as Falun Dafa, is a spiritual discipline that has been persecuted by the Chinese communist regime since 1999.

Several officers broke into Mr. Yang Shiyi's home on February 20, 2023 and took him to the Xiangtan City Detention Center. The police called his son the next day and asked him to deliver some clothes to his father. They also claimed that Mr. Yang and five other practitioners put up banners bearing information about Falun Gong and that they managed to catch him (while the other five practitioners escaped). But Mr. Yang denied having ever put up the alleged banners.

Uyghurs

15.03.2023 - Uyghur Christian released after 15-year sentence

ChinaAid confirmed that Uyghur Christian **Alimujiang Yimiti** was released from prison after his 15-year sentence. While other details are unconfirmed, the Uyghur house church pastor is home with his family.

Alimujiang Yimiti, also known as Alim, converted from Islam to Christianity in 1995 and served as a house church pastor to Uyghurs in Kashgar, Xinjiang. His work in Xinjiang painted a target on his back, as the Chinese government began to scrutinize Uyghurs in the area. In 2007, authorities initially accused Alim of using his business to “infiltrate” Christian ideology into Kashgar.

Alim was criminally detained on Jan. 12, 2008, for “inciting separatism” and “unlawfully providing state secrets to overseas organizations” due to a conversation he had with an American colleague, possibly about his interaction with authorities in 2007.

15.03.2023 - The “Buddhist and Taoist clergy database,” another CCP imposture

With great fanfare, the China Buddhist Association and China Taoist Association have launched in Beijing’s Guangji Temple, at the end of last month, the Buddhist and Taoist Clerical Personnel Information Query System.

Those attending the press conference saw the slogan, “Fake monks and priests now have nowhere to hide!” displayed prominently. The speakers insisted that both Chinese and tourists have been defrauded by fake monks and Taoist priests asking for alms. Indeed, that these incidents have occurred is not false, although tourists in popular temples have been more easily fooled than Chinese believers. Also, temples where tourists are taken are managed by the China Buddhist Association and the China Taoist Association, which are supposed to keep their own houses in order.

10.03.2023 - Wang Liqin heavily surveilled after visiting her imprisoned husband.

Following meeting procedures for China’s prisons, Wang Liqin successfully met her imprisoned husband Wang Zang for the first time in three years. A few days later, Wang Liqin was immediately monitored around the clock by 24 government personnel. She

posted a video revealing this information, and the authorities threatened her and her four children.

Dissident poet Wang Zang's wife, Wang Li (given name: Wang Liqin), has been under strict surveillance since March 2. When she went out to buy groceries, 5 people followed and even filmed her. Wang Li took a video of them and posted it on Twitter. Beginning on the 3rd, the number of surveillance personnel increased from 12 to 24, divided into four shifts.

Bitter Winter has reported how the Early Rain Covenant Church in Chengdu, theoretically liquidated in 2018 before his pastor Wang Yi was sentenced to nine years in jail in 2019, continues to gather "illegally" by changing locations every Sunday, in a cat and mouse game with the police.

The game continued on May 5, according to a report shared by the house church members with Bitter Winter and other human rights media. Some twelve church members were blocked at home since Friday; one sister had the tires of her car punctured; another had to deal with the fact that water and electricity supplies to her home had been cut off, a frequent harassment strategy against church members. Four believers were taken to the police station on Sunday.

06.03.2023 - 'Smart religion' app: christians must submit online form to attend church.

Christians in Henan province, China, must complete an online form and receive approval to attend church services. Officials refer to applications for church gatherings as a form of governance for "Smart Religion," but no legal basis has been provided for such a measure.

Henan has one of the largest Christian populations in China. According to the "Smart Religion" requirements formulated by Henan's provincial religious department, if religious believers want to participate in religious activities, they must make online reservations before they can attend services in churches, mosques, or Buddhist temples.

Local believers must register and make an appointment through an application called "Smart Religion," developed by the Ethnic and Religious Affairs Commission of Henan Province.

The "Mayflower Church" was established in 2012 as Shenzhen Holy Reformed. Due to Pastor Pan Yongguang's ordination in the United States, police interrogated him about his connection to overseas groups.

14.03.2023 - Drug experiment on incarcerated Falun Dafa practitioner

A resident of Xindian Town, Xingtai City, Hebei Province, was incarcerated for three years after she spoke up for Falun Dafa. The police arrested **Ms. Qiao Yunxia**, then 37, on October 25, 1999, for appealing for the right to practice Falun Dafa and gave her three years of forced labor in Shijiazhuang City Women's Forced Labor Camp, where she was tortured because she refused to renounce her faith.

The guards shocked her with electric batons, force-fed her chili powder, hung her up, suffocated her with wet towels, and beat her. As she stayed firm in her faith, the guards put unknown drugs in her food and subjected her to various tests in a hospital.

10.03.2023 - Falun Gong's report on persecution in 2022: 172 killed, 633 sentenced

Just as The Church of Almighty God does, Falun Gong also publishes an annual report on the persecution it is subject to in China. The 2023 report, covering the year 2022, has now been released.

It claims that 172 Falun Gong practitioners died in 2022 as a result of the persecution, bringing the total to 4,984 (or more, as the Falun Gong organization abroad believes the data it collects from China are incomplete) since the crackdown started in 1999.

China weakens itself by suppressing civil society and silencing independent voices

Unconstrained by civil society and democratic institutions, Xi Jinping has set China on a dangerous course.

[RFA](#) (09.03.2023) - Chinese leaders aspire to global economic, political, and even spiritual leadership. But unless the Chinese Communist Party relaxes its suffocating restrictions on civil society, Chinese citizens won't be able to fulfill their creative and human potential. Without independent assessments of the utility and moral integrity of its policies, no government can understand its errors and make changes, and keep its own power in check.

Free access to information strengthens society, but in 2017, Chinese leader Xi Jinping [explained](#) that "the [CCP] manages the media by putting all media at all levels under the leadership of the party."

Censorship disadvantages the Chinese people in comparison to their counterparts in democratic societies. They are deprived of full access to scientific facts, historical and social scientific research, and the humanistic contributions and political debates that broaden our thinking and allow informed reflection on the challenges and possibilities of life in society. Instead, most of the Chinese people have access only to what the state allows. All public information and opinion are shaped in ways that putatively ensure the stability of the regime, not reflecting the objective reality of events.

Xi, now safely ensconced in a third term as top leader of the Communist Party, is using this year's session of China's rubber-stamp parliament, the National People's Congress, to push [structural changes](#) that would tighten party control over security, intelligence, scientific and technological institutions, as well as over financial institutions--consolidating more political power in his hands. This will also choke the flow of information.

In free societies, schools and universities have been incubators for new ideas and techniques, and for the development of individual character. But in China, education and research at all levels has been co-opted to control the people's knowledge and understanding through propaganda, according to official directives on "[adhering to political standards](#)" and "[strengthening and improving ideological and political work](#)" at the primary, secondary, and university levels.

Xi's support for "[think tanks with Chinese characteristics](#)" serves as an evidence for the suppression of independent research and thought. According to an Opinion [published](#) in 2015, the basic principle is to "adhere to the Party's leadership." In August 2019, an independent think tank promoting economic liberalism and constitutional democracy was [shut down](#) because it was deemed "unregistered and unauthorized."

Clearly, the CCP-ruled government is afraid of independent research and thought it cannot control. Since its release in November last year, [ChatGPT](#), an artificial intelligence application, has amassed over 100 million users, and aroused a flurry of activity as engineers race to incorporate AI into their products. In China, Baidu is trying to keep pace with its Ernie Bot. But restrictions imposed by censorship and surveillance put it at a severe disadvantage. China's industrial sector and overall economy is the loser.

What is even worse is how the Chinese state imposes itself on the moral and spiritual life of the people. Despite being peaceful and non-political, religious movements not under state control are ruthlessly persecuted; in 2022, for example, more than 10,000 members of the Church of Almighty God were arrested, with over 3,000 tortured and 14 killed, according the [Church's records](#). China has become the world's worst abuser of religious freedom, violently suppressing other minority communities like Falun Gong, Buddhism, and, in a region-wide program of incarceration and torture in Xinjiang, Islam.

Protestant Christianity is [growing faster](#) in China than anywhere on Earth, by about [10 percent](#) annually. Today there are about 38 million believers, up from 22 million just a

decade ago. If this trend holds by 2030, China could be the ["world's most Christian nation."](#)

Because the government insists on being the sole source of authority and meaning for the Chinese people, the authorities feel threatened by this dramatic development, itself a sign of the spiritual vacuousness of Marxist materialism. Against the growth of religious denominations, the government has responded with violent crackdowns and persecution, as well as by clumsy efforts to insert state ideology and propaganda into Christian houses of worship.

Following a 2017 [regulation](#), the State should "actively guide religion to adapt to socialist society" and "practice the core values of socialism." In April 2016, at the [National Religious Work Conference](#), Xi stated: "Providing active guidance for the adaptation of religions to socialist society is to guide religious believers to love the motherland and the people, safeguard the unity of the motherland and... uphold the leadership of the Chinese Communist Party and the socialist system." At another [conference](#) in 2021, Xi stressed the need to guide religious figures and believers to "cultivate and practice the core values of socialism."

The CCP degrades and subjugates historical faiths, attempting to make them into propaganda tools, as Stalin did with the Russian Orthodox Church. But in claiming to [construct](#) a "spiritual civilization," and pretending socialism is a religion, Xi has drawn upon a language of religious idealism, and thus inadvertently validated their moral power. In Tibet, so many images of Xi saturate daily existence that party bosses [claim](#) many Buddhists consider him a living Bodhisattva.

By promoting the belief that he is some form of deity, Xi is mimicking, and revealing his envy of the transcendental faith he has tried to stamp out. But while arrogating to himself unlimited power in both the political and spiritual realm, unconstrained by civil society and democratic institutions, he has also set China on a course that is dangerous to itself, and to other societies.

Ms. Zhang died on January 31, 2023, at age 69. She was predeceased by her husband and their son, who both developed heart diseases after being traumatized by her repeated harassment, arrest, and detention. Her son died on September 24, 2014, and her husband passed away on February 16, 2017.

However, after three years, there is the risk that news about the persecution of the CAG in China would have a lesser impact on Western audiences, due to a phenomenon called "persecution fatigue," which scholars have studied with respect to the kidnapping and killing of thousands of Christians in Nigeria.

In 2014, when the first Christian girls in Nigeria were kidnapped, raped, and in some cases killed, U.S. First Lady Michelle Obama joined hundreds of other celebrities throughout the world and was photographed holding a poster "Bring Back Our Girls." After nine years, unfortunately kidnapping and killing Christians in Nigeria has become routine, and news about it struggle to find a few lines in the internal pages of the Western newspapers.

The same may happen with the CAG in China. With the exception of Bitter Winter, not many media remind the world that the persecution continues. The CAG itself publishes a yearly report with data on the persecution, and [the report for 2022](#) has been published last

week. Somebody may object that these data come from the CAG itself: how can we be sure that they are true? The answer is that for the precise figures we should trust the CAG, but the CAG or Bitter Winter are not the only or even the main source about the movement's persecution in China.

The first source is the Chinese government itself. It has [a specialized website](#) coordinating the fight against religious movements banned as "[xie jiao](#)" ("heterodox teachings," sometimes translated as "evil cults") in China, operated by a China Anti-Xie-Jiao association that is an emanation of the Chinese Communist Party ([CCP](#)). Every week, this website hails the success of the Chinese police in fighting the [xie jiao](#), and dozens of articles chronicle the arrest, prosecution, and sentencing to heavy jail terms of CAG members throughout China. Local national and Chinese media also publish the same news from time to time, and they confirm that the figures offered by the CAG's own reports are highly believable.

What are these figures? While admitting that its statistics may be incomplete, the CAG reports that "between 2011 and the end of 2022, more than 430,000 CAG Christians were arrested by the Chinese authorities, and the documented number of believers who have died as a result of persecution since the Church's establishment has reached 231." Additionally, "at least 10,895 CAG Christians were arrested in 2022; of them, 3,257 were subjected to torture" or psychological pressure, and "1,901 were given prison sentences.

Of those sentenced, 1002 received sentences of three years or more, 116 received sentences of seven years or more, and 19 were given heavy sentences of 10 years or more." An additional source is the Association for the Defense of [Human Rights](#) and Religious Freedom (ADHRRF), which [has published information](#) on 4,056 CAG members detained in the year 2022 in its database of prisoners of conscience. It should be added that "a total of at least RMB 240 million (approximately USD \$35.37 million) in assets were appropriated and illegally held from [The Church of Almighty God](#) and its members by the [CCP](#) in 2022."

2022 was the third year of the [CCP's](#) campaign, called an "all-out war," seeking a "final solution" to eradicate the CAG. The preparation of the 20th National Congress of the [CCP](#) saw a "Clean-up 2022" special operation launched to further suppress the CAG.

The report states that, "Out of all the provinces nationwide, persecution in Anhui and Jiangsu was most severe; by the end of December, the number of known arrests of [CAG] Christians in Jiangsu totaled 1,343, while in Anhui it totaled 1,360." Sentences were heavy, particularly against those CAG believers who sent evidence of the CAG persecution to foreign media, including Bitter Winter. This was, for example, the only "crime" for which a CAG member was sentenced to the long jail term of 15 years in 2022.

According to the report, at least 14 CAG members were victims of extra-judicial killings. They included Liu Jianjun, a 50-year-old believer from Jiangsu who, as it often happens in China, was detained in an hotel for secret interrogation. He died after ten days.

"The autopsy showed a large, blunt trauma to the head, blood clotting in the cranium and chest cavity, three fractured ribs, and no food residue in the stomach or intestines," meaning he had not been given any food during his last days. Zhu Xiaohong, a 37-year-old woman, also from Jiangsu, committed suicide after several days of torture. When relatives could see her body, they noticed that "her entire face was swollen, there were

wounds on her right cheekbone, blood in the corners of both eyes, and both nostrils were bloodstained.”

Others, including Huang Fenfang in Jiangxi and Fan Limin in Shandong, were not properly cured after the authorities had learned they had cancer. When she started having health problems, Huang was not allowed to cease the hard labor she was subjected to. She “was required to fold between 2,400 and 3,200 joss paper ingots every day, and was made to stand for long periods without rest as punishment if she didn’t complete the allotted amount.” “The [detention house](#) food was very poor-quality, lacking oil and salt, and rations were meager.” Doctors admitted to the family that Huang’s cancer “was directly correlated with her depression, inadequate nutrition, and hard labor in jail.”

Several believers reported torture. Wu Hua, a 58-year-old female victim of the crackdown in Jiangsu [province](#), reported she was interrogated about the church’s situation in her area. As she would not cooperate, “They locked each of her hands and feet separately to ring buckles on the interrogation chair so that her entire body was dangling off the chair, taped a jug of water to the front of her chest, and then picked up the chair and swung it around forcefully.”

Before she almost miraculously managed to escape, Wu was tortured again. “They locked each of her hands and feet separately to ring buckles on the interrogation chair so that her entire body was dangling off the chair, taped a jug of water to the front of her chest, and then picked up the chair and swung it around forcefully,” the report says.

A 48-year-old believer from Henan reported that “the police smacked her across the face dozens of times, then used the ‘threading the rod’ form of torture on her, cuffing both her hands and feet, making her squat down and hug her knees, threading a wooden rod behind her knees and in front of her arms, then lifting her up so her body was suspended. One officer hit her on the soles of her feet with a rubber rod while another continued smacking her in the face.”

They then “used a suspension form of torture, handcuffing both her wrists and hanging her from a pole by the handcuffs, then tying her right foot to the rod with a rope so that her left leg was dangling in the air. One officer hit her repeatedly in the right foot with a rubber rod while another smacked her in the face, beating her and interrogating her simultaneously. They continued this torture until she lost consciousness again. The questioning continued after the police used water to awaken her. They used metal rods to viciously beat her in the ribs, making her tremble uncontrollably in pain, and also electrocuted her with electric batons until she passed out.”

These stories continue for pages and pages, and those wanting to have a complete picture should read the 2022 report, as well as the reports for the previous years. They can also read my Oxford book, where I report several torture and extra-judicial killing cases based on sworn affidavits by those who were tortured and managed to escape abroad (in some cases, supported by medical records), and by eyewitnesses and relatives in the cases of those who died.

These affidavits were also filed as enclosures to complaints lodged with the United Nations [Human Rights Council](#). While there are no affidavits in the 2022 report, the fact that the stories there are so similar to those documented in my book certainly supports the conclusion that they are true.

This means that nothing has changed since 2020. During and after the COVID lockdown, the [CCP](#) has continued to persecute, arrest, torture, and in some cases kill, thousands of CAG members in China. Again, you should not take CAG's or Bitter Winter's word for it. There are plenty of [CCP](#)'s own documents and reports in the Chinese media proving that the Chinese authorities have vowed to eradicate the CAG "like a tumor," as they said, without regard for the beliefs, [human rights](#), liberty, or life of the devotees they so mercilessly persecute.

Ngaba (Ch. Ngawa) Tibetan and Qiang Autonomous Prefecture (population one million) in Sichuan is part of historical Tibet, although it is outside present-day Tibet Autonomous Region (TAR). The majority of its population is Tibetan.

In a way, the situation in Ngaba Prefecture is worse than in the TAR. Seoul Sungrak Church: One of the world's largest Baptist Churches banned as a "cult" in China

China's desire to please Korean anti-cultists, with whom it regularly cooperates, may have been a factor in the decision.

Bitter Winter (19.01.2023) - <https://bit.ly/3XsSe3e> - "Xie jiao." This is the verdict for the Berea Church, the Chinese branch of the Seoul Sungrak Church. [Bitter Winter reported in 2018](#) that a secret [United Front](#) working group was organizing a crackdown on this church, and [again in 2019](#) that Sungrak had become a main target in a campaign against Christian groups active in China and headquartered in South Korea.

"Xie jiao," as readers of Bitter Winter know, is an old Chinese label used since the Middle Ages to ban as "heterodox teachings" movements regarded as hostile to the governments. The word is translated in English-language official Chinese documents as "cults."

The most current [list of movements banned as xie jiao](#) does not include the Seoul Sungrak Church or its affiliates. However, the government-controlled [Three-Self Church](#) has written this month to its affiliate churches that the Berea/Sungrak Church should be considered as a [xie jiao](#), as it has been banned in the provinces of Heilongjiang, where Berea has its Chinese headquarters, Liaoning, Fujian, Shandong, and Zhejiang. Indeed, it is a common way to become a [xie jiao](#) for all practical and legal purposes to be listed as such at the provincial rather than the national level.

Bitter Winter has learned that pastors and believers have been interrogated in Liaoning and Heilongjiang, and some have been detained. "We do not criticize the government and we mind our own business, a lay church leader from Harbin, Heilongjiang, told Bitter Winter. We were never harassed until the [Three-Self Church](#) and the China Anti-Xie-Jiao Association started cooperating on a regular basis with movements fighting 'heresies' in Korea." "The latter, according to the believer, do not like us because we are one of the fastest-growing church in South Korea and their churches lose members who come to us. China should have nothing to do with these disputes, but it wants to please the Korean heresy hunters because they help them fighting [Falun Gong](#) and [The Church of Almighty God](#)."

The Sungrak Seoul Church was founded by Pastor Kim Ki Dong in 1969. Although he had been educated as a Presbyterian, and his style of worship was Pentecostal, he decided to affiliate himself with the Korean Baptist Convention. Pastor Kim's church grew so fast that it was listed among the fastest growing churches in the world, and one of the largest Baptist congregations internationally (today, it has some 170,000 members).

Because of this growth, it was accused of "sheep-stealing" by the powerful Korean Presbyterian churches, which persuaded the Korean Baptist Convention to expel Sungrak in 1987, citing an inappropriate emphasis on Pentecostal rather than Baptist practices and on demonology and exorcism. However, at that stage Sungrak was large enough to create its own rival Baptist Convention and keep the contacts with American and other Baptist bodies.

"There are other fine theological points where we disagree with Presbyterians and with some other Baptists, the Harbin leader told us. However, they know these are not the real reasons they attack us. They do not like us because we grew too fast. They have persuaded the Chinese to call us a [xie jiao](#) for the same reason."

Mr Nu's younger brother Nu Sangkai, Mr San's girlfriend Liu Yanlan and two other Christians who participated in the same gathering were subsequently placed under administrative detention by police in Fugong county on 12 January. The grounds for their detention are as yet unknown.

Villages in the Nujiang Grand Canyon have significant numbers of Protestant Christians, and the area is known as "the Gospel Valley" due to its rich missionary legacy. The recent detentions are indicative of an increasing crackdown on churches in the area, some of which were established by Western missionaries in the early 20th century. One source told CSW that 'it seems that the authorities want to root out the Christian faith' from the area.

In a [document](#) dated February 2022, the Policy and Regulation Division of the Yunnan Provincial Ethnic and Religious Commission stated: 'Religious issues in Yunnan are intertwined with ethnic and border issues, and there are more hidden problems and emergencies in the religious field.'

China's 2017 [Regulations on Religious Affairs](#) prohibit preaching in schools but do not prohibit under-18s from entering religious sites. However, the authorities in many provinces, including Guizhou, [Hubei](#), [Qinghai](#), [Shanxi](#), [Tibet](#) and Yunnan, have issued their own sets of religious regulations which proscribe 'organising, inducing or forcing minors to participate in religious activities.' This effectively renders any religious youth work illegal.

The offence of 'organising and sponsoring an illegal gathering', which was added to China's Criminal Code in 2015, carries a custodial sentence of up to three years. In August 2022, [Geng Zejun](#), a preacher from the Rock Church in Shizuishan, Ningxia, was convicted and jailed for one year and three months on this charge.

CSW's Founder President Mervyn Thomas said: ***'It is alarming to see more people detained for participating in a private Christian gathering, just before the Chinese New Year festivities. CSW calls for the immediate release of all Christians in Yunnan and Ningxia who are currently deprived of their liberty arbitrarily and unjustly. Again, we urge the Chinese authorities to respect the right of all citizens, including children and young people, to freedom of thought, conscience and religion or belief. China must end the targeting of religious leaders who choose not to register with the government, those who work among ethnic minority communities and those who teach children and youth groups.'***

06.01.2023 - Prison art from China's Ming Dynasty reflects a restriction of religious freedom

USCIRF charges China's authorized religious bodies as Communist Party accomplices

A new report exposes the five authorized religions' "complicity in the government's systematic, ongoing, and egregious violations of religious freedom."

The "red market" includes the [five authorized religions](#): five government-controlled bodies that constitute the only legal religious organizations in China. They are the [Three-Self Church](#) for Protestants, the [Chinese Patriotic Catholic Association](#) for Catholics, the [China Daoist Association](#) for Daoists, the [China Islamic Association](#) for Muslims, and the [China Buddhist Association](#) for Buddhists.

The "black market" includes the groups singled out by the regime and banned as "xie jiao" ("heterodox teachings," sometimes translated as "evil cults"), which are mercilessly persecuted. In the middle lies the largest segment of China's religious life, the "gray market" of communities that refuse to join the [five authorized religions](#) and are regarded as illegal although they are not banned as [xie jiao](#): Protestant [house churches](#), [Catholic conscientious objectors](#) who refuse the [Vatican-China deal of 2018](#), independent Daoist and Buddhist temples and Islamic mosques. Under [Xi Jinping](#), life has become increasingly precarious for those in the "gray market" too.

The United States Commission on International Religious Freedom (USCIRF) is an independent U.S. bipartisan commission whose members are designated by the congressional leaders of both parties and appointed by the President. On December 29, it has released [a new report](#) on "State-Controlled Religion and Religious Freedom Violations in China," which focuses on the role the [five authorized religions](#) play in the Chinese system of anti-religious repression. We are thankful for the repeated references to Bitter Winter, including to [an important article by Marco Respinti](#) that exposed China's strategy for installing a Dalai Lama of its own when the current 14th Dalai Lama will die.

The report denounces the [five authorized religions'](#) "complicity in the government's systematic, ongoing, and egregious violations of religious freedom." It carefully explains how the five organizations exist not to promote religion but to control, limit, and transform it into a propaganda tool for the Chinese Communist Party (CCP). This role is not secret, the report notes. It is clearly spelled out in the by-laws of the five organizations, in [Xi Jinping's](#) speeches, and in the 2020 "Measures on the Administration of Religious Groups." The five bodies are defined as "patriotic religious organizations," "with an express purpose to 'unite and guide' members of their respective religious communities to 'support the leadership of the Chinese Communist Party and the socialist system.'"

In practice, the report explains, this means that they "assist or work with the [CCP](#) and government in promulgating, implementing, and enforcing state laws, regulations, and policies—often at the expense of the religious communities they claim to represent." They are asked to offer their support in tracking down, denouncing, and persecuting the [xie jiao](#) and other forms of "illegal" religion, and they do it zealously.



They lead their affiliates to study the [CCP](#) documents and the writings and speeches of [Xi Jinping](#). They make sure that authorized places of worship are “forced to display Communist propaganda posters, including images and quotes of Communist leaders such as [Xi Jinping](#) and [Mao Zedong](#), although the display of such images violates religious principles of some religions. Moreover, state-sanctioned clergy members are forced to incorporate [CCP](#) ideology and policies into their sermons or speeches.”

While the [five authorized religions](#) play their negative role throughout the whole of China, the report notes that their complicity with the [CCP](#) is specially obvious in [Xinjiang](#) and in Tibet. There, they assist the Communist Party in its repression of genuine expressions of Islam and Buddhism, and try to hide it through propaganda disseminated internationally. In Tibet, the [China Buddhist Association](#) is increasingly taking the lead in the [CCP](#) strategy aimed at installing a fake Dalai Lama of its own when the present Dalai Lama will die.

The report concludes that “State-controlled religious organizations remain an integral part of the [CCP](#)’s institutional control of religion. These organizations are expected to be absolutely loyal to the [CCP](#), to serve as conduits and endorsers of state propaganda, and to facilitate the implementation of the [CCP](#)’s religious policies—notably the deeply coercive policy on the [sinicization](#) of religion.

The integral involvement of these state-controlled religious organizations in such repression renders them complicit in the [CCP](#)’s systematic, ongoing, and egregious religious freedom violations. On the other hand, these religious organizations are also ironically victims of the [CCP](#)’s religious policy; they are deprived of genuine practice of religion without state interference, and any perceived disloyalty and public disagreement with the [CCP](#) and government leads to severe punishment.”

The USCIRF report never mentions the Vatican. However, by recommending that after the 2018 agreement (renewed in 2020 and 2022) Catholics join the [Chinese Patriotic Catholic Association](#), the Holy See is implicitly criticized for directing Chinese believers to become part of an organization exposed as an accomplice of brutal violations of religious freedom.
